



RWANDA STOCK EXCHANGE MARKET REPORT FOR THURSDAY 29TH OCTOBER 2020

1. Market overview

- Today's trading session recorded on the equities market a total of Frw 373,000 from 4,700 shares traded in 4 deals and Frw 4,392,000 worth of bonds on the fixed income market.
- RSI and ALSI went up 0.12 and 0.02 points to close at 108.72 and 147.92 respectively.
- BOK counter closed at Frw 230 (Frw 230 previous). The trading session recorded a total turnover of Frw 115,000 from 500 shares traded in 1 deal.
- CTL counter closed at Frw 72 (Frw 70 previous). The trading session recorded a total turnover of Frw 144,000 from 2,000 shares traded in 1 deal.
- IMR counter closed at Frw 45 (Frw 45 previous). The trading session recorded a total turnover of Frw 90,000 from 2,000 shares traded in 1 deal.
- CMR counter closed at Frw 120 (Frw 120 previous). The trading session recorded a total turnover of Frw 24,000 from 200 shares traded in 1 deal.
- Equities counters closed as follows: BLR: Frw 118; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526.

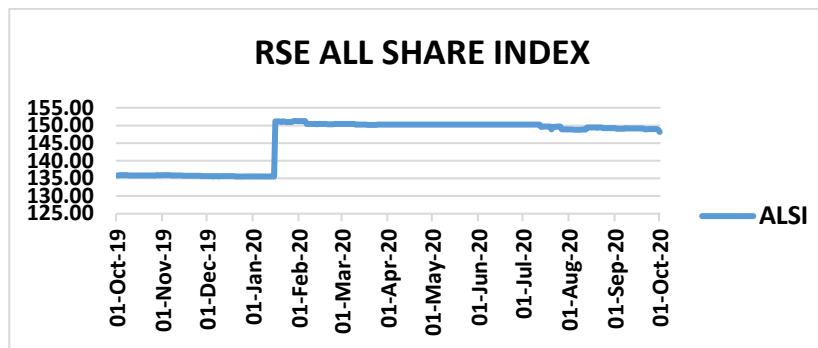
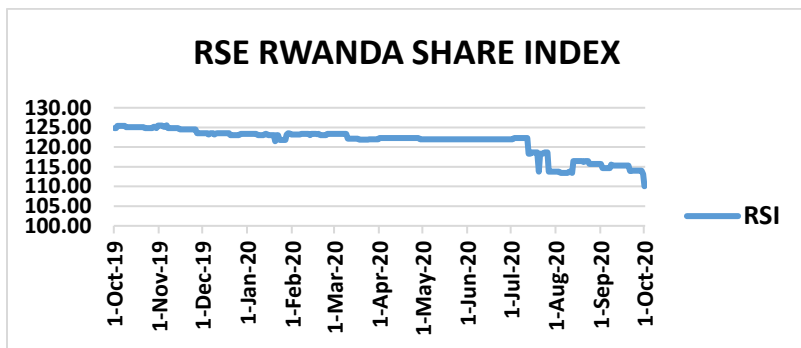
