



## RWANDA STOCK EXCHANGE MARKET REPORT FOR THURSDAY 29<sup>TH</sup> SEPTEMBER 2022

### 1. Market overview

- The trading session recorded a turnover of Frw 289,068,000 worth of bonds traded in 2 deals on the fixed income market and Frw 5,062,300 from 30,300 shares traded in 8 deals on the equities market.
- RSI and ALSI remained constant to close at 109.61 and 147.59 respectively.
- BOK counter closed at Frw 272 (Frw 272 previous). The trading session recorded a total turnover of Frw 1,244,200 from 4,600 shares traded in 3 deals.
- IMR counter closed at Frw 43 (Frw 43 previous). The trading session recorded a total turnover of Frw 105,100 from 2,500 shares traded in 2 deals.
- BLR counter closed at Frw 170 (Frw 170 previous). The trading session recorded a total turnover of Frw 3,713,000 from 23,200 shares traded in 3 deals.

- Equities counters closed as follows: CMR: Frw 120; MTNR: Frw 176; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

### 2. Closing bell

At the end of the formal trading hours; On the BOK counter, there were outstanding offers of 371,600 shares between Frw 272 - 290 and an outstanding bid of 15,000 shares at Frw 265. On MTNR counter, there were outstanding offers of 1,409,800 shares between Frw 176 - 180 and no bids. On BLR counter, there was an outstanding offer of 12,800 shares at Frw 170 and no bids. On IMR counter, there were outstanding offers of 166,800 shares between Frw 43 - 45 and no bids. On CMR counter, there were outstanding offers of 105,800 shares at Frw 120 and no bids.

On the bonds market, there were no offers and no bids.

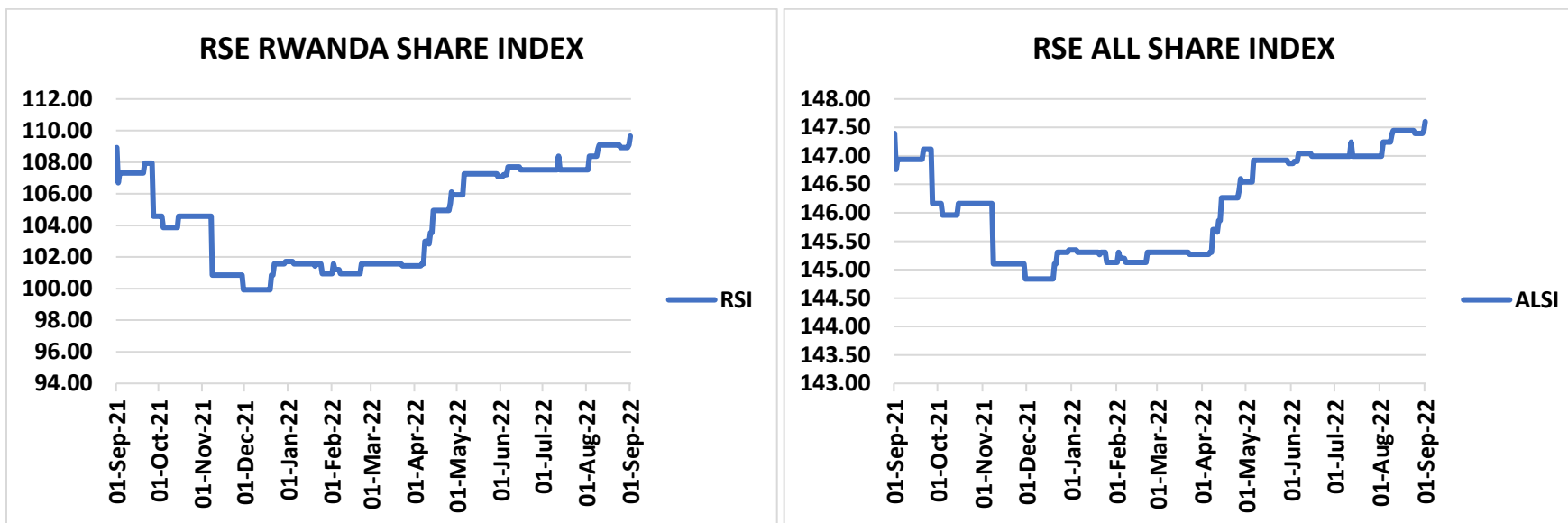
