



RWANDA STOCK EXCHANGE MARKET REPORT FOR THURSDAY 30TH DECEMBER 2021

1. Market overview

- The trading session recorded a turnover of Frw 14,699,720 worth of bonds traded in 4 deals on the fixed income market and Frw 201,600 from 1,600 BLR shares traded in 1 deal on the equities market.
- RSI and ALSI went up by 0.14 and 0.04 points to close at 101.71 and 145.34 respectively.
- BLR counter closed at Frw 126 (Frw 125 previous). The trading session recorded a total turnover of Frw 201,600 from 1,600 shares traded in 1 deal.
- Equities counters closed as follows: BOK: Frw 250; IMR: Frw 45; CMR: Frw 120; MTNR: Frw 180; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

2. Closing bell

At the end of the formal trading hours; On BOK counter, there was an outstanding offer of 40,000 shares at Frw 250 and no bids. On MTNR counter, there were outstanding offers of 652,000 shares between Frw 180-195 and no bids. On BLR counter, there were outstanding bids of 105,000 shares between Frw 116-125 and no offers. On CMR counter, there was an outstanding offer of 100,000 shares at Frw 120 and no bids. On IMR counter, there were outstanding offers of 899,900 shares between Frw 45-47 and no bids.

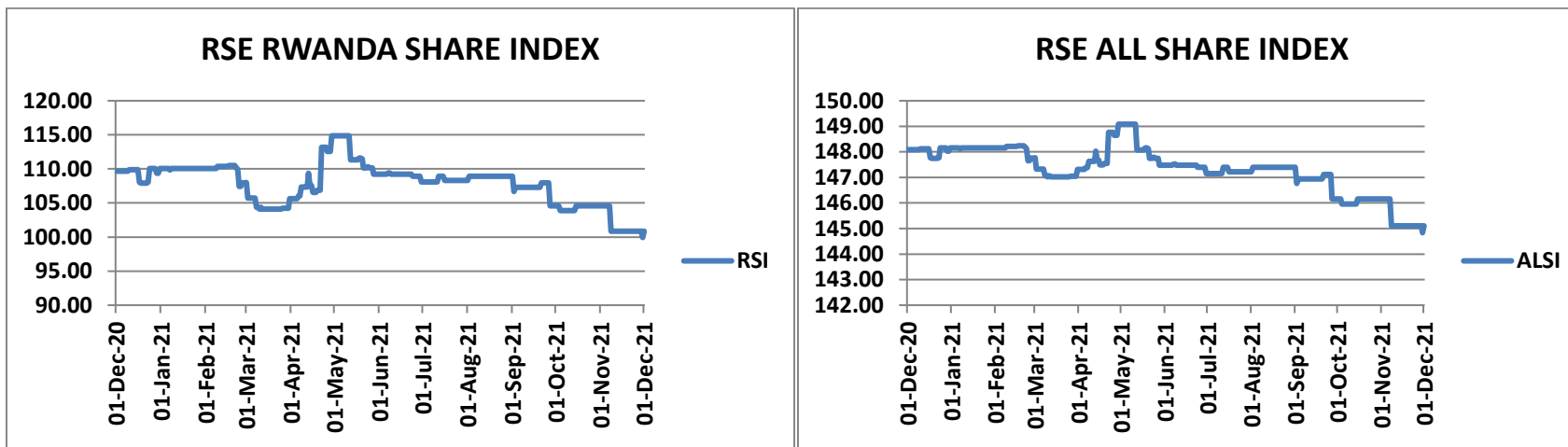
