



RWANDA STOCK EXCHANGE MARKET REPORT FOR THURSDAY 30TH MARCH 2023

1. Market overview

- The trading session recorded a turnover of Frw 518,777,800 worth of bonds traded in 7 deals on the fixed-income market and Frw 27,181,700 from 165,700 shares traded in 6 deals on the equities market.
- RSI and ALSI went up by 0.28 and 0.08 points to close at 109.84 and 142.80 respectively.
- BLR counter closed at Frw 175 (Frw 173 previous). The trading session recorded a total turnover of Frw 26,844,500 from 157,900 shares traded in 4 deals.
- IMR counter closed at Frw 45 (Frw 45 previous). The trading session recorded a total turnover of Frw 337,200 from 7,800 shares traded in 2 deals.
- Equities counters closed as follows: BOK: Frw 270; CMR: Frw 120; MTNR: Frw 173; EQTY: Frw 440; KCB: Frw 328; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

2. Closing bell

At the end of the formal trading hours; On the BOK counter, there were outstanding offers of 18,600 shares between Frw 271 - 280 and an outstanding bid of 1,300 shares at Frw 270. On MTNR counter, there were outstanding offers of 975,700 shares between Frw 173 - 190 and no bids. On BLR counter, there were outstanding offers of 53,400 shares at Frw 175 and no bids. On IMR counter, there were outstanding offers of 232,100 shares at Frw 45 and no bids. On CMR counter, there were outstanding bids of 25,100 shares between Frw 122 – 130 and no offers.

On the bonds market, there were no offers and no bids.

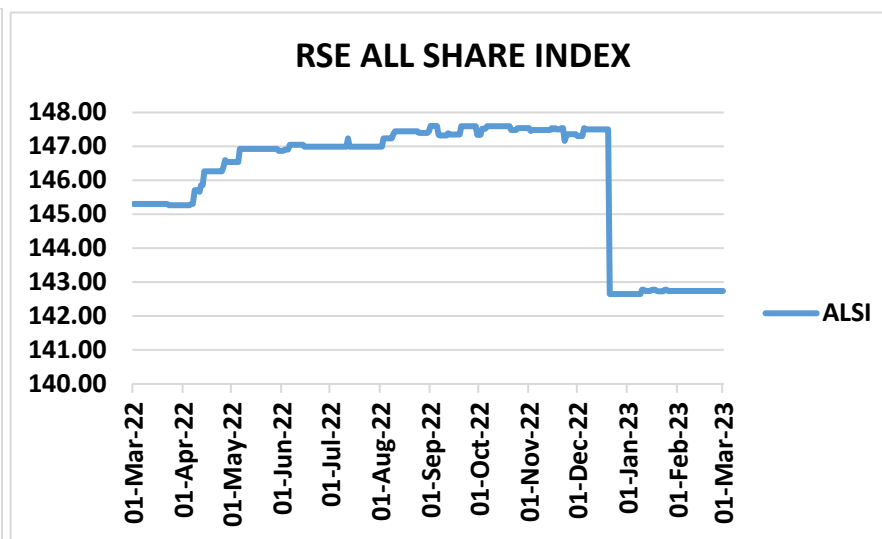
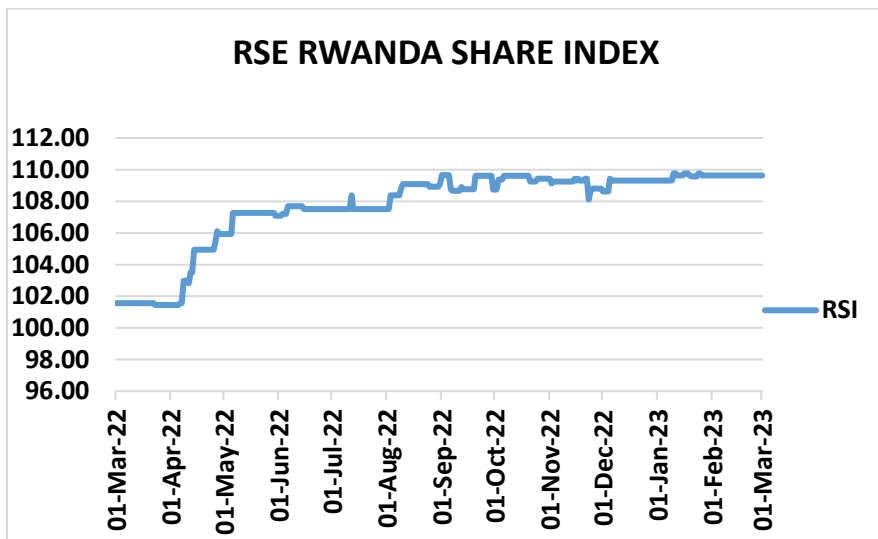
