



RWANDA STOCK EXCHANGE MARKET REPORT FOR TUESDAY 03RD NOVEMBER 2020

1. Market overview

- Today's trading session recorded on the fixed income market a total of Frw 10,578,000 worth of bonds traded in 2 deals while the equities market recorded Frw 1,142,000 from 16,600 shares with CTL decreasing 2 points to Frw 70.
- RSI and ALSI went down 0.12 and 0.02 points to close at 108.46 and 147.85 respectively.
- IMR counter closed at Frw 45 (Frw 45 previous). The trading session recorded a total turnover of Frw 36,000 from 800 shares traded in 1 deal.
- CTL counter closed at Frw 70 (Frw 72 previous). The trading session recorded a total turnover of Frw 1,106,000 from 15,800 shares traded in 2 deals.
- Equities counters closed as follows: BOK: Frw 230; BLR: Frw 118; CMR: Frw 120; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526.

2. Closing bell

At the end of the formal trading hours, on BOK counter, there were outstanding offers of 290,200 shares between Frw 230-240 and no bids. On BLR counter, there were outstanding offers of 113,300 shares between Frw 122-136 and no bids. On CTL counter, there were outstanding offers of 92,300 shares between Frw 70-75 and an outstanding bid of 30,000 shares at Frw 65. On IMR counter, there were outstanding offers of 306,700 shares between Frw 45-47 and no bids. On CMR counter, there was an outstanding offer of 100,000 shares at Frw 120 and no bids.

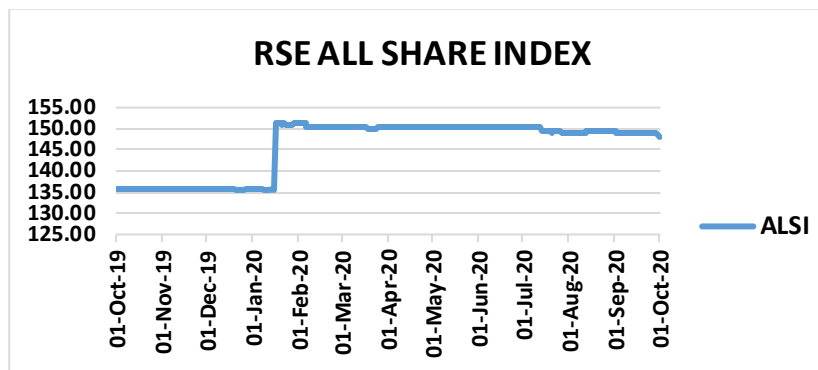
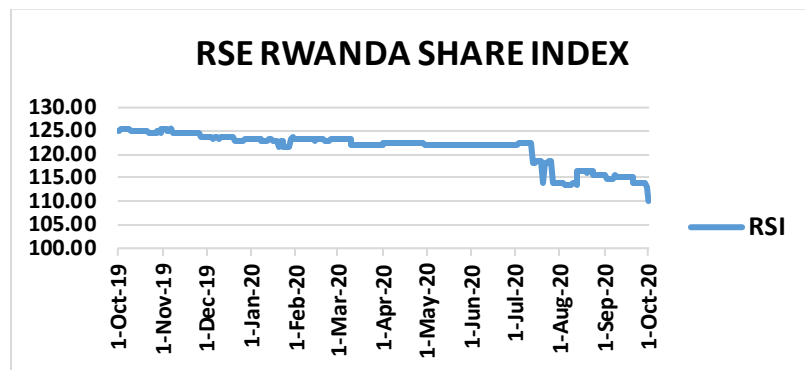
