



## RWANDA STOCK EXCHANGE MARKET REPORT FOR TUESDAY 04<sup>TH</sup> JANUARY 2022

### 1. Market overview

- The trading session recorded a total turnover of Frw 475,000 from 2,600 shares traded in 2 deals on the equities market while the fixed income market remained quiet.
- RSI and ALSI remained constant to close at 101.71 and 145.34 respectively.
- BOK counter closed at Frw 250 (Frw 250 previous). The trading session recorded a total turnover of Frw 25,000 from 100 shares traded in 1 deal.
- MTNR counter closed at Frw 180 (Frw 180 previous). The trading session recorded a total turnover of Frw 450,000 from 2,500 shares traded in 2 deals.
- Equities counters closed as follows: BLR: Frw 126; IMR: Frw 45; CMR: Frw 120; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

### 2. Closing bell

At the end of the formal trading hours; On BOK counter, there was an outstanding offer of 39,900 shares at Frw 250 and no bids. On MTNR counter, there were outstanding offers of 653,800 shares between Frw 180-195 and no bids. On BLR counter, there were outstanding bids of 100,500 shares between Frw 116-125 and no offers. On CMR counter, there was an outstanding offer of 100,000 shares at Frw 120 and no bids. On IMR counter, there were outstanding offers of 905,300 shares between Frw 45-47 and no bids.

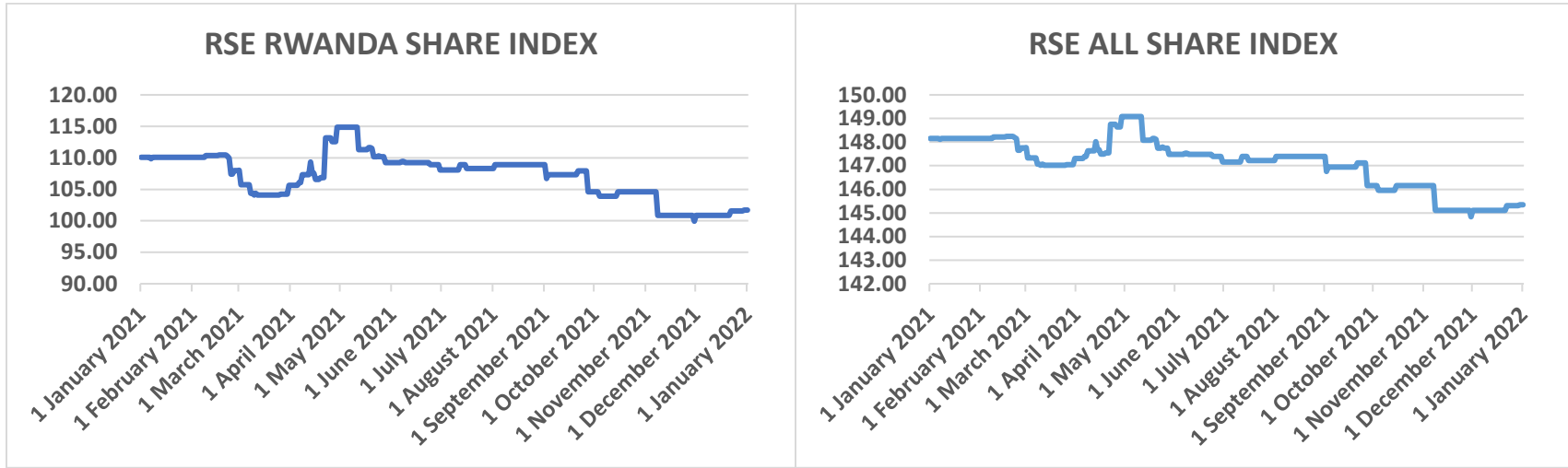
