



RWANDA STOCK EXCHANGE MARKET REPORT FOR TUESDAY 04TH OCTOBER 2022

1. Market overview

- The trading session recorded a turnover of Frw 900,306,100 worth of bonds traded in 4 deals on the fixed income market and Frw 43,118,900 from 271,800 shares traded in 8 deals on the equities market.
- RSI and ALSI remained constant to close at 109.36 and 147.52 respectively.
- MTNR counter closed at Frw 176 (Frw 176 previous). The trading session recorded a total turnover of Frw 42,152,000 from 263,400 shares traded in 4 deals.
- BOK counter closed at Frw 270 (Frw 270 previous). The trading session recorded a total turnover of Frw 675,000 from 2,500 shares traded in 1 deal.
- IMR counter closed at Frw 43 (Frw 43 previous). The trading session recorded a total turnover of Frw 231,900 from 5,400 shares traded in 2 deals.
- CMR counter closed at Frw 120 (Frw 120 previous). The trading session recorded a total turnover of Frw 60,000 from 500 shares traded in 1 deal.

- Equities counters closed as follows: BLR: Frw 170; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

2. Closing bell

At the end of the formal trading hours; On the BOK counter, there was an outstanding offer of 50,000 shares at Frw 280 and outstanding bids of 900 shares at Frw 272. On MTNR counter, there were outstanding offers of 1,510,100 shares between Frw 176 - 180 and no bids. On BLR counter, there was an outstanding offer of 9,300 shares at Frw 170 and no bids. On IMR counter, there were outstanding offers of 144,300 shares between Frw 43 - 45 and no bids. On CMR counter, there were outstanding offers of 105,200 shares at Frw 120 and no bids.

On the bonds market, there were no offers and no bids.

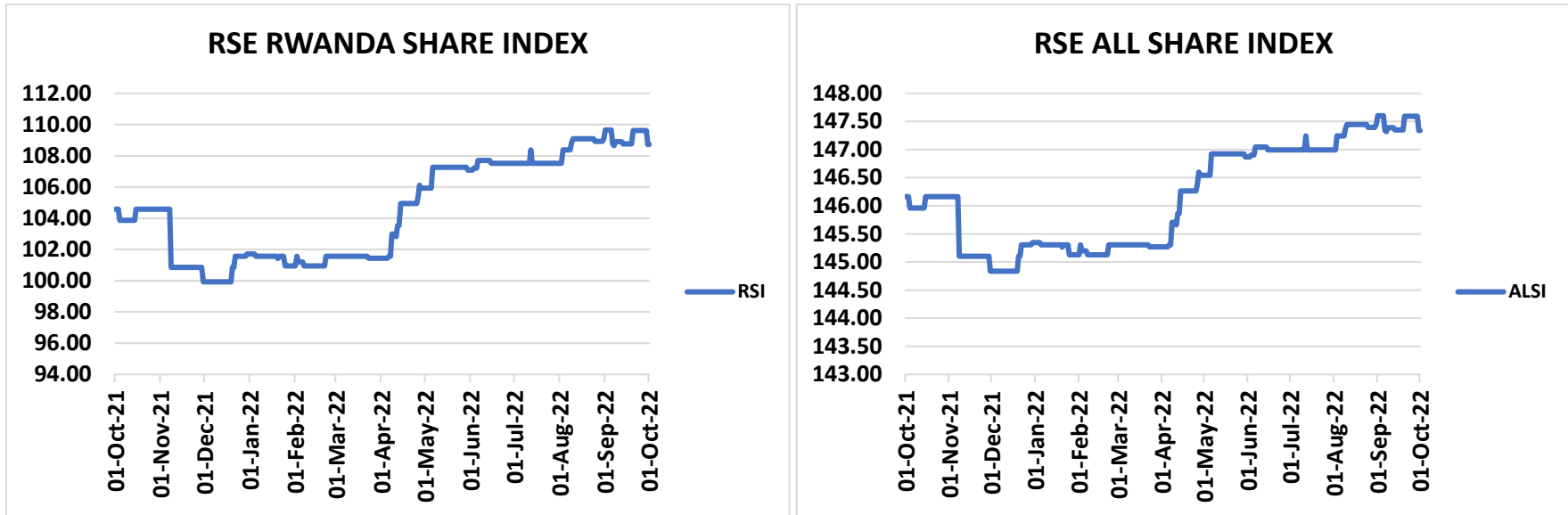
