



## RWANDA STOCK EXCHANGE MARKET REPORT FOR TUESDAY 06<sup>TH</sup> SEPTEMBER 2022

### 1. Market overview

- The trading session recorded a turnover of Frw 51,460,000 worth of bonds traded in 1 deal on the fixed income market and Frw 1,550,800 from 18,000 shares traded in 4 deals on the equities market.
- RSI and ALSI went down by 0.90 and 0.25 points to close at 108.74 and 147.34 respectively.
- MTNR counter closed at Frw 176 (Frw 180 previous). The trading session recorded a total turnover of Frw 1,055,200 from 6,200 shares traded in 2 deals.
- IMR counter closed at Frw 42 (Frw 43 previous). The trading session recorded a total turnover of Frw 495,600 from 11,800 shares traded in 2 deals.

- Equities counters closed as follows: BLR: Frw 165; BOK: Frw 272; CMR: Frw 120; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

### 2. Closing bell

At the end of the formal trading hours; On the BOK counter, there was an outstanding offer of 356,900 shares at Frw 290 and an outstanding bid of 23,000 shares between Frw 245 - 265. On MTNR counter, there were outstanding offers of 1,133,700 shares between Frw 176 - 180 and no bids. On BLR counter, there were outstanding offers of 65,800 shares between Frw 160 - 165 and no bids. On IMR counter, there were outstanding offers of 71,800 shares at Frw 43 and no bids. On CMR counter, there were outstanding offers of 100,000 shares at Frw 120 and no bids.

On the bonds market, there were no offers and no bids.

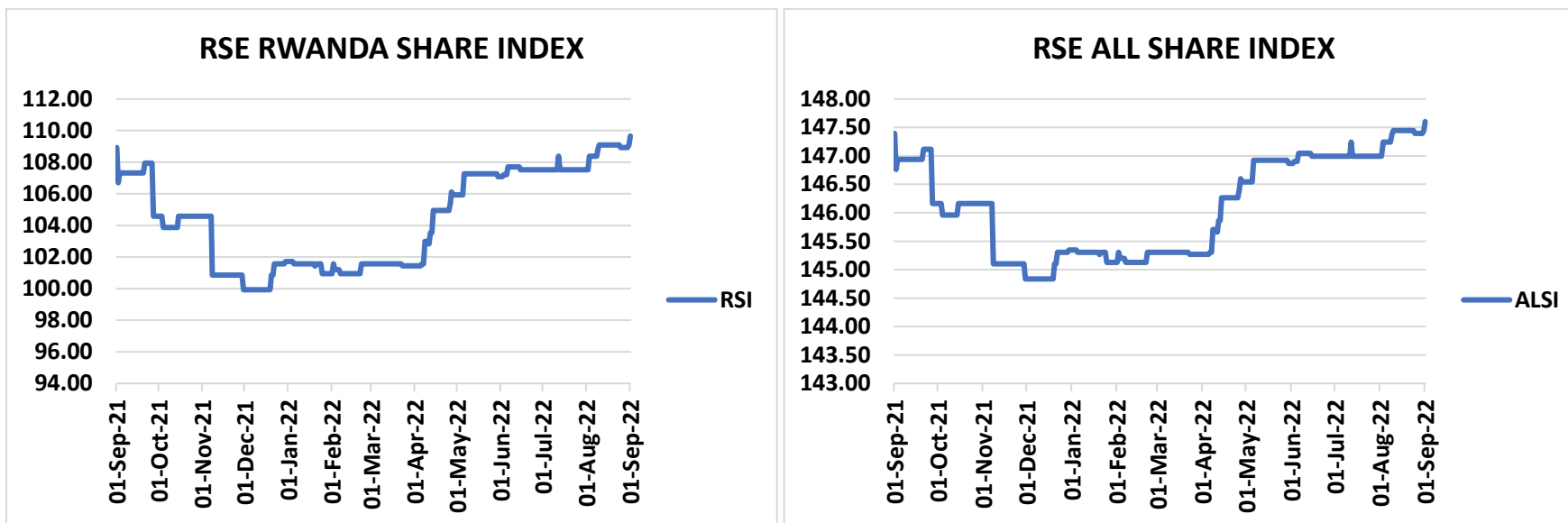
