



RWANDA STOCK EXCHANGE MARKET REPORT FOR TUESDAY 07TH FEBRUARY 2023

1. Market overview

- Today's trading session recorded a turnover of Frw 188,768,000 worth of bonds traded in 3 deals on the fixed-income market while the equities market remained quiet.
- RSI and ALSI remained constant to close at 109.63 and 142.74 respectively.
- Equities counters closed as follows: BLR: Frw 170; BOK: Frw 271; IMR: Frw 45; CMR: Frw 120; MTNR: Frw 175; EQTY: Frw 440; KCB: Frw 328; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

2. Closing bell

At the end of the formal trading hours; On the BOK counter, there were outstanding offers of 42,800 shares between Frw 271 - 272 and no bids. On MTNR counter, there were outstanding offers of 1,237,100 shares between Frw 175 - 180 and no bids. On BLR counter, there were outstanding offers of 2,100 shares at Frw 170 and an outstanding bid of 61,000 shares between Frw 160-164. On IMR counter, there were outstanding offers of 252,900 shares at Frw 45 and an outstanding bid of 200 shares at Frw 43. On CMR counter, there was an outstanding bid of 1,000 shares Frw 122 and no offers.

On the bonds market, there were no offers and no bids.

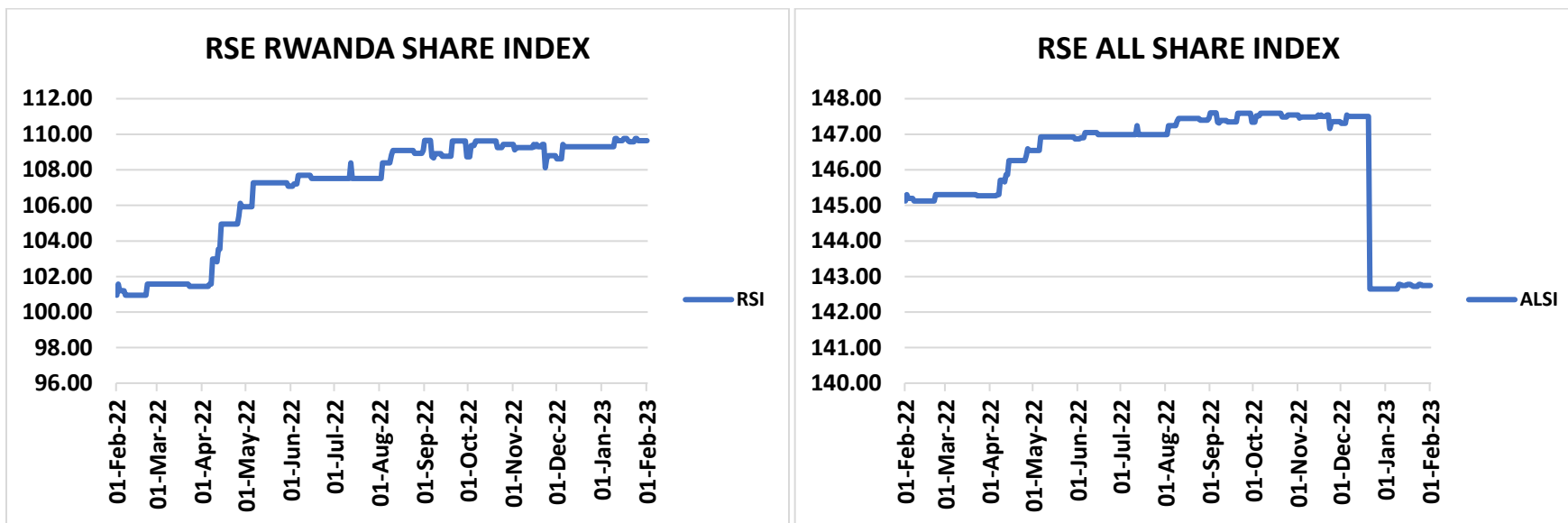
