



## RWANDA STOCK EXCHANGE MARKET REPORT FOR TUESDAY 09<sup>TH</sup> FEBRUARY 2021

### 1. Market overview

- Today's trading session recorded on the fixed income market Frw 347,469,500 worth of bonds traded in 3 deals while the equities market recorded Frw 3,024,500 from 43,300 shares traded in 3 deals.
- RSI and ALSI went up 0.30 and 0.05 points to close at 110.35 and 148.21 respectively.
- IMR counter closed at Frw 45 (Frw 45 previous). The trading session recorded a total turnover of Frw 544,500 from 12,100 shares traded in 1 deal.
- CTL counter closed at Frw 80 (Frw 75 previous). The trading session recorded a total turnover of Frw 2,480,000 from 31,200 shares traded in 2 deals.
- Equities counters closed as follows: BOK: Frw 233; BLR: Frw 121; CMR: Frw 120; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526.

### 2. Closing bell

At the end of the formal trading hours, on BOK counter, there were outstanding offers of 223,700 shares between Frw 227-240 and no bids. On BLR counter, there were outstanding offers of 151,800 shares between Frw 120-136 and no bids. On CTL counter, there were outstanding bids of 264,700 shares between Frw 67- 80 and no offers. On IMR counter, there were outstanding offers of 1,157,900 shares at Frw 45 and no bids. On CMR counter, there was an outstanding offer of 100,000 shares at Frw 120 and no bids.

On bonds market, there was no offer and no bids

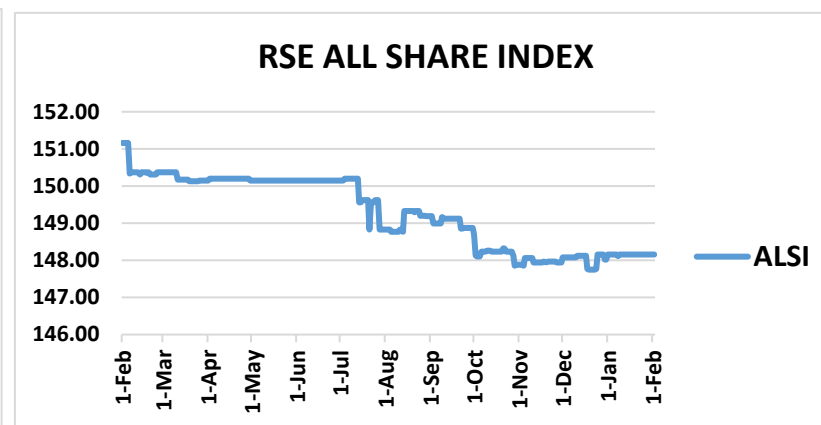
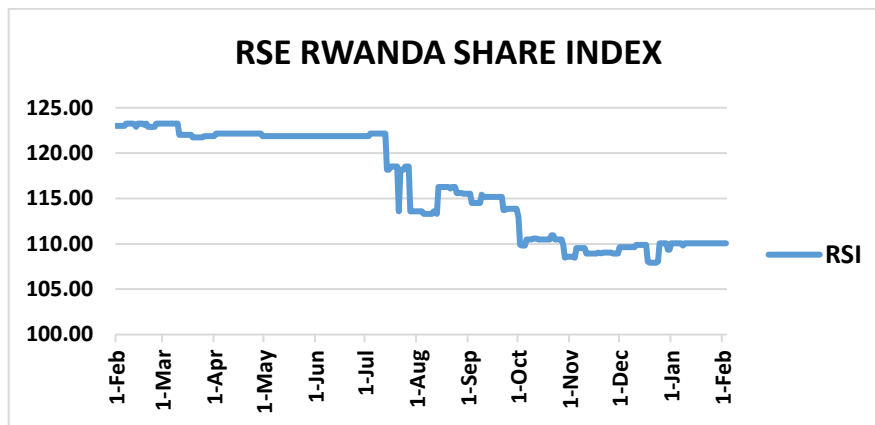
