



RWANDA STOCK EXCHANGE MARKET REPORT FOR TUESDAY 11TH JANUARY 2022

1. Market overview

- The trading session recorded a turnover of Frw 663,023,850 worth of bonds traded in 5 deals on the fixed income market and Frw 627,000 from 2,900 shares traded in 2 deals on the equities market.
- RSI and ALSI remained constant to close at 101.57 and 145.30 respectively.
- MTNR counter closed at Frw 180 (Frw 180 previous). The trading session recorded a total turnover of Frw 252,000 from 1,400 shares traded in 1 deal.
- BOK counter closed at Frw 250 (Frw 250 previous). The trading session recorded a total turnover of Frw 375,000 from 1,500 shares traded in 1 deal.
- Equities counters closed as follows: BLR: Frw 125; IMR: Frw 45; CMR: Frw 120; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

2. Closing bell

At the end of the formal trading hours; On BOK counter, there were outstanding offers of 40,000 shares at Frw 250 and an outstanding bid of 5,000 shares at Frw 245. On MTNR counter, there were outstanding offers of 652,400 shares between Frw 180-195 and no bids. On BLR counter, there was an outstanding offer of 600 shares at Frw 125 and an outstanding bid of 100,000 shares at Frw 116. On CMR counter, there was an outstanding offer of 100,000 shares at Frw 120 and no bids. On IMR counter, there were outstanding offers of 603,200 shares between Frw 45-47 and no bids.

On the bonds market; there were no offers and no bids.

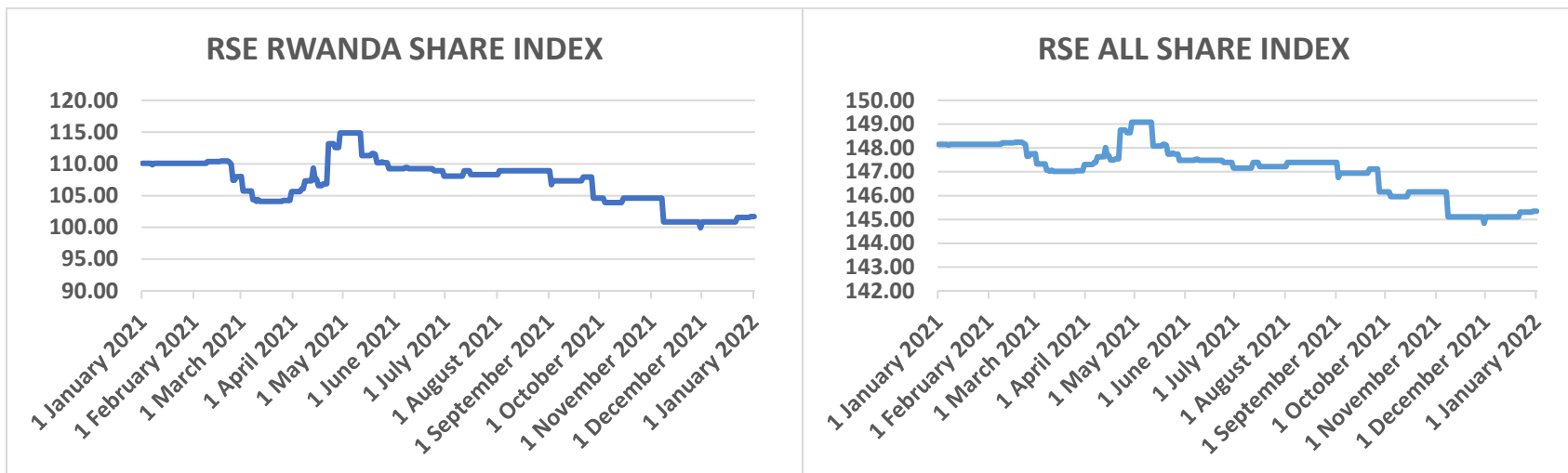
