



## RWANDA STOCK EXCHANGE MARKET REPORT FOR TUESDAY 13<sup>TH</sup> SEPTEMBER 2022

### 1. Market overview

- The trading session recorded a turnover of Frw 200,878,000 from 1,225,000 shares traded in 3 deals on the equities market and Frw 136,674,000 worth of bonds traded in 4 deals on the fixed income.
- RSI and ALSI went down by 0.14 and 0.04 points to close at 108.77 and 147.35 respectively.
- BLR counter closed at Frw 164 (Frw 165 previous). The trading session recorded a total turnover of Frw 196,800,000 from 1,200,000 shares traded in 1 deal.
- MTNR counter closed at Frw 176 (Frw 176 previous). The trading session recorded a total turnover of Frw 4,078,000 from 25,000 shares traded in 2 deals.
- Equities counters closed as follows: BOK: Frw 272; IMR: Frw 43; CMR: Frw 120; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

### 2. Closing bell

At the end of the formal trading hours; On the BOK counter, there were outstanding offers of 737,300 shares between Frw 272 - 290 and outstanding bids of 23,000 shares between Frw 245 - 265. On MTNR counter, there were outstanding offers of 1,133,400 shares between Frw 176 - 180 and no bids. On IMR counter, there were outstanding offers of 76,800 shares at Frw 43 and no bids. On CMR counter, there were outstanding offers of 101,700 shares at Frw 120 and no bids.

On the bonds market, there were no offers and no bids.

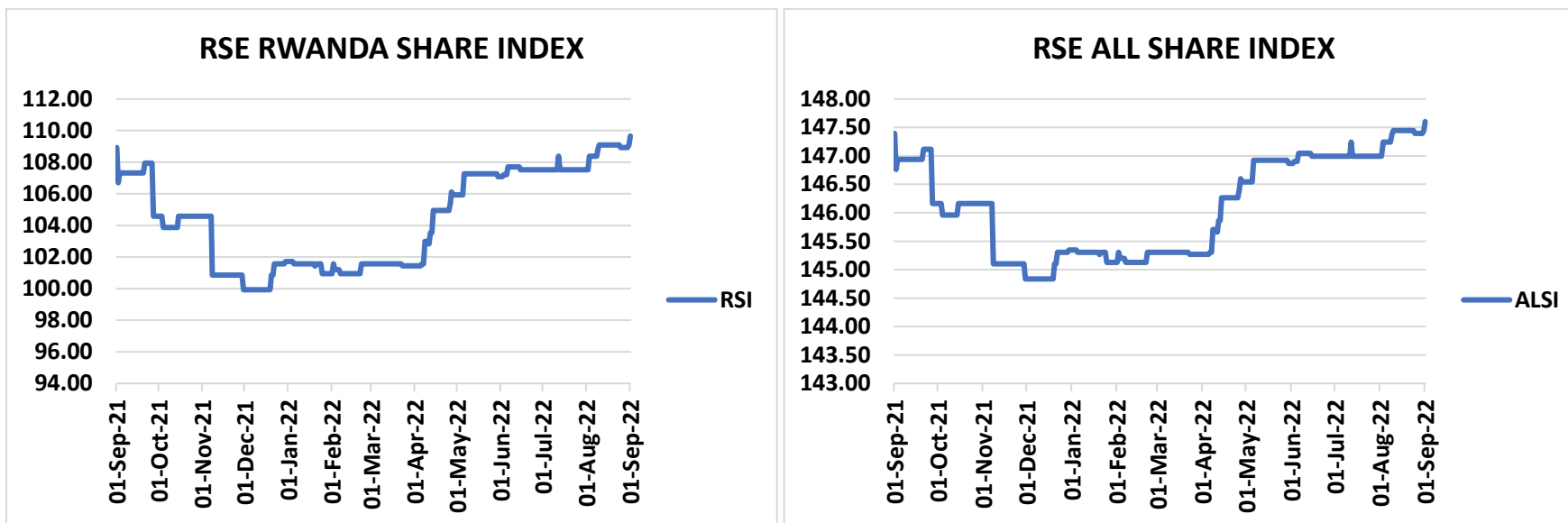
