### 1. Market overview

- Both RSI and ALSI remained constant to close at 123.40 and 135.58 respectively.
- Today's trading session recorded a total of Frw 17,867,500 worth of bond traded in 6 deals.
- Equities counters closed as follows: CTL: Frw 70; BOK: Frw 265; BLR: Frw 139; IMR: Frw 90; KCB: Frw 370; EQTY: Frw 350; NMG: Frw 1200 and USL: Frw 104.

### 2. Closing bell

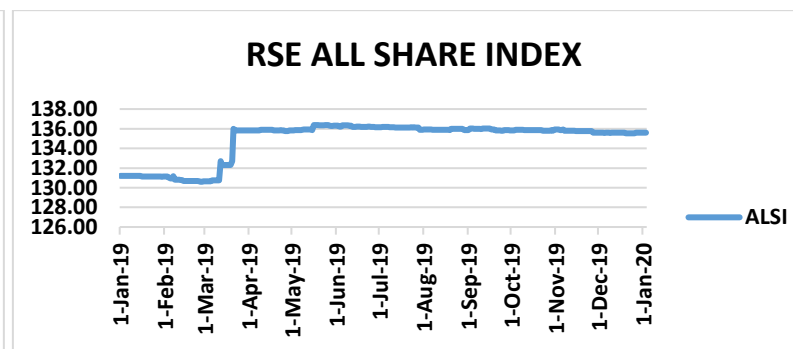
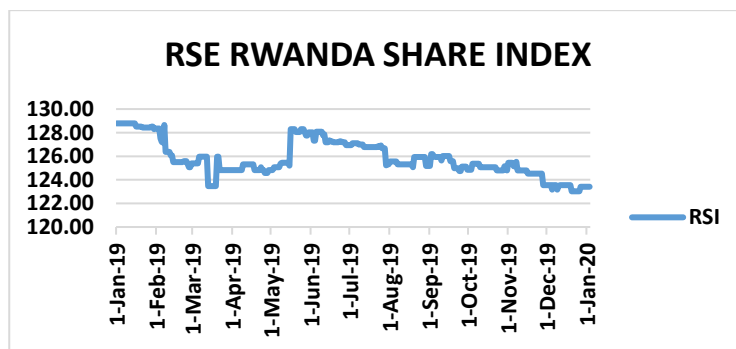
