1. Market overview

- Today's trading session recorded a total turnover of Frw 623,000 worth of bonds traded in 2 deals on the fixed income market while the equities market remained quiet.
- RSI and ALSI remained constant to close at 107.31 and 146.93 respectively.
- Equities counters closed as follows: BLR: Frw 120; BOK: Frw 245; IMR: Frw 45; CMR: Frw 120; MTNR: Frw 218; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

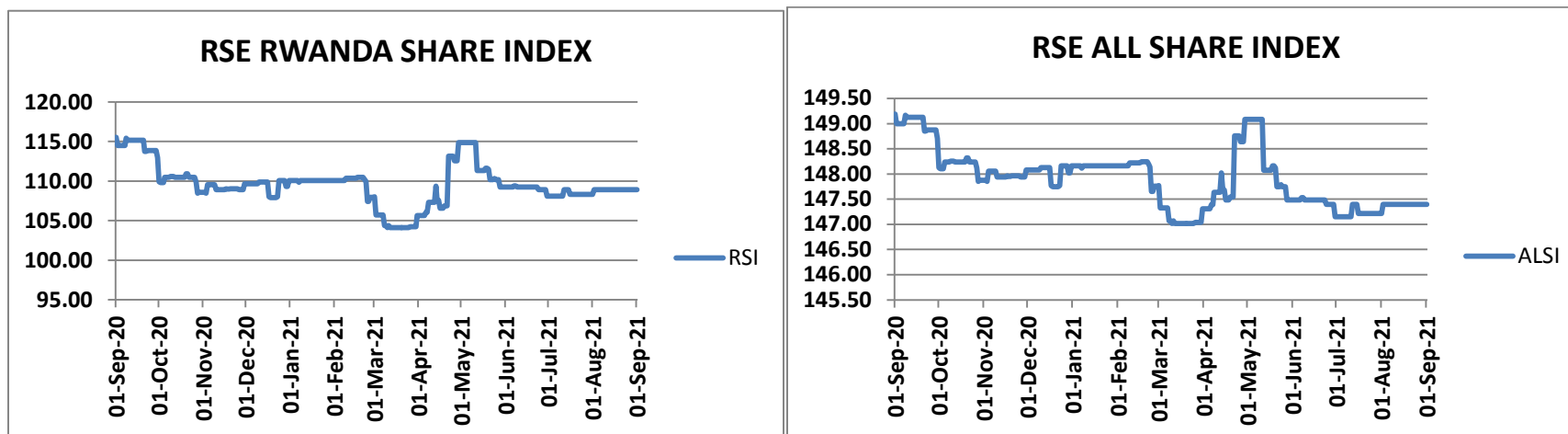
