



RWANDA STOCK EXCHANGE MARKET REPORT FOR TUESDAY 15TH NOVEMBER 2022

1. Market overview

- The trading session recorded a total turnover of Frw 105,000 from 600 MTNR shares traded in 1 deal on the equities market while the fixed income market remained quiet.
- RSI and ALSI went up by 0.18 and 0.05 points to close at 109.43 and 147.53 respectively.
- MTNR counter closed at Frw 175 (Frw 174 previous). The trading session recorded a total turnover of Frw 105,000 from 600 shares traded in 1 deal.
- Equities counters closed as follows: BLR: Frw 170; BOK: Frw 272; IMR: Frw 43; CMR: Frw 120; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

2. Closing bell

At the end of the formal trading hours; On the BOK counter, there were outstanding offers of 101,300 shares between Frw 272 - 280 and no bids. On MTNR counter, there were outstanding offers of 1,225,600 shares between Frw 175 - 180 and no bids. On IMR counter, there were outstanding offers of 312,800 shares between Frw 43 - 45 and no bids. On CMR counter, there was an outstanding offer of 100,000 shares at Frw 120 and no bids.

On the bonds market, there were outstanding offers of Frw 26,500,000 worth of bonds between Frw 102.7 – 106 and no bids.

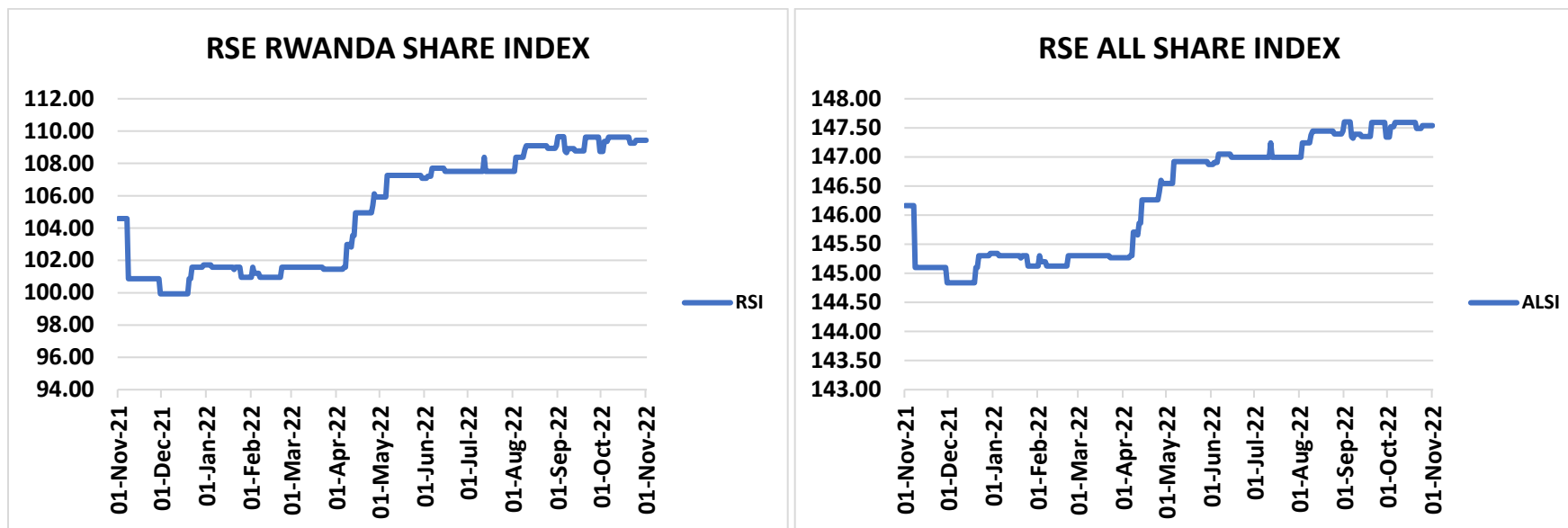
