



RWANDA STOCK EXCHANGE MARKET REPORT FOR TUESDAY 16TH AUGUST 2022

1. Market overview

- The trading session recorded a turnover of Frw 106,164,000 worth of bonds traded in 3 deals on the fixed income market and Frw 557,300 from 7,600 shares traded in 4 deals on the equities market.
- RSI and ALSI remained constant to close at 109.10 and 147.44 respectively.
- BOK counter closed at Frw 272 (Frw 272 previous). The trading session recorded a total turnover of Frw 244,800 from 900 shares traded in 1 deal.
- IMR counter closed at Frw 43 (Frw 43 previous). The trading session recorded a total turnover of Frw 279,500 from 6,500 shares traded in 2 deals.
- BLR counter closed at Frw 165 (Frw 165 previous). The trading session recorded a total turnover of Frw 33,000 from 200 shares traded in 1 deal.
- Equities counters closed as follows: CMR: Frw 120; MTNR: Frw 177; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

2. Closing bell

At the end of the formal trading hours; On the BOK counter, there were outstanding offers of 356,900 shares at Frw 290 and an outstanding bid of 8,000 shares at Frw 265. On MTNR counter, there were outstanding offers of 1,030,300 shares between Frw 177 - 180 and no bids. On BLR counter, there were outstanding offers of 98,800 shares between Frw 165 - 176 and an outstanding bid of 3,000 shares at Frw 160. On IMR counter, there were outstanding offers of 242,800 shares between Frw 43 - 45 and no bids. On CMR counter, there were outstanding offers of 112,000 shares at Frw 120 and no bids.

On the bonds market, there were no offers and no bids.

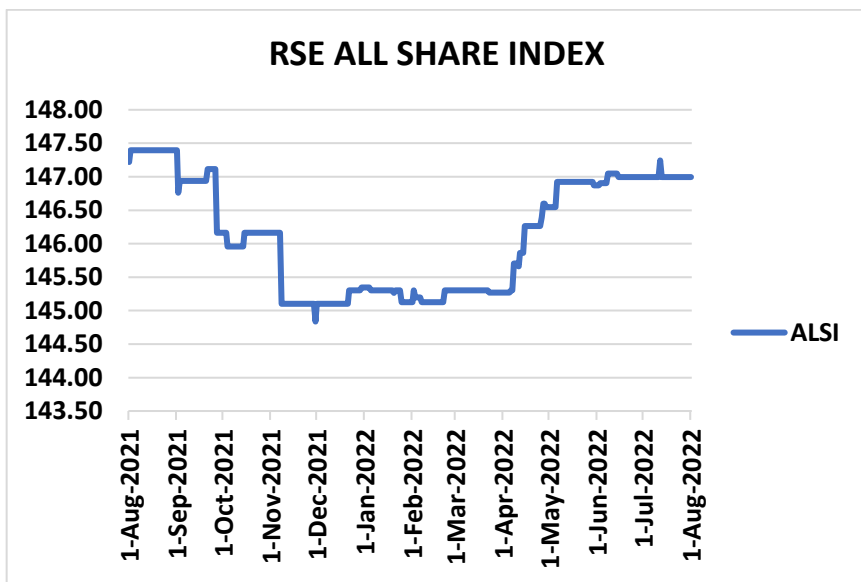
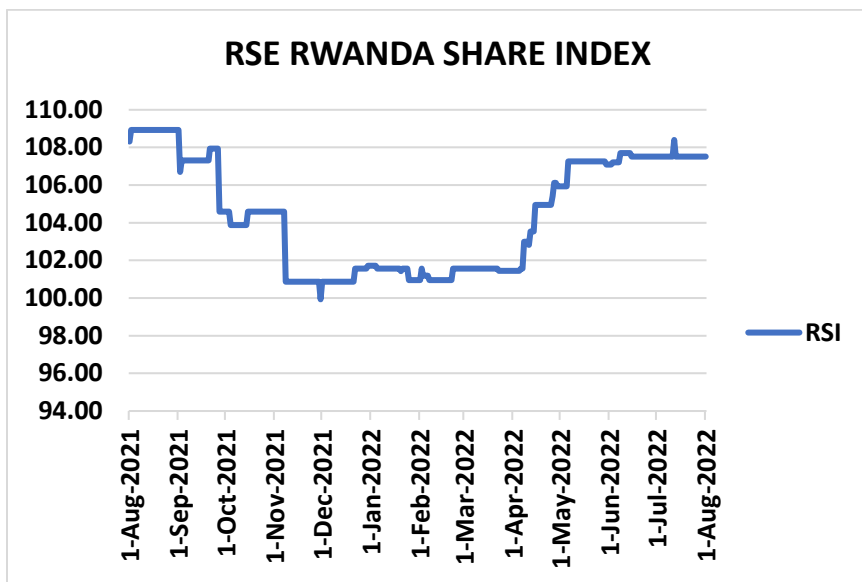
