

RWANDA STOCK EXCHANGE MARKET REPORT FOR TUESDAY 16[™] NOVEMBER 2021

1. Market overview

- Today's trading session recorded a turnover of Frw 61,598,000 from 321,300 shares traded in 3 deals on the equities market and Frw 17,184,480 worth of bonds traded in 3 deals on the fixed income market.
- RSI and ALSI remained constant to close at 100.86 and 145.10 respectively.
- MTNR counter closed at Frw 180 (Frw 180 previous). The trading session recorded a total turnover of Frw 47,628,000 from 264,600 shares traded in 1 deal.
- BOK counter closed at Frw 250 (Frw 250 previous). The trading session recorded a total turnover of Frw 13,925,000 from 55,700 shares traded in 1 deal.
- IMR counter closed at Frw 45 (Frw 45 previous). The trading session recorded a total turnover of Frw 45,000 from 1,000 shares traded in 1 deal.

EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and
RHB: Frw 526

On BLR counter, there were outstanding offers of 41,800 shares at Frw 120 and outstanding bids of 110,000 shares between Frw 115-116. On CMR counter, there was an outstanding offer of 100,000 shares at Frw 120 and no bids. On IMR counter, there were outstanding offers of 293,600 shares between Frw 45-47 and no bids.


