



RWANDA STOCK EXCHANGE MARKET REPORT FOR TUESDAY 17TH NOVEMBER 2020

1. Market overview

- Today's trading session recorded on the equities market a total of Frw 923,400 with CTL increasing 2 points to Frw 72 while the fixed income market was quiet.
- RSI and ALSI went up 0.12 and 0.02 points to close at 109.04 and 147.96 respectively.
- IMR counter closed at Frw 45 (Frw 45 previous). The trading session recorded a total turnover of Frw 765,000 from 17,000 shares traded in 1 deal.
- CTL counter closed at Frw 72 (Frw 70 previous). The trading session recorded a total turnover of Frw 158,400 from 2,200 shares traded in 1 deal.
- Equities counters closed as follows: BLR: Frw 120; BOK: Frw 230; CMR: Frw 120; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526.

2. Closing bell

At the end of the formal trading hours, on BOK counter, there were outstanding offers of 177,000 shares between Frw 230-240 and no bids. On BLR counter, there were outstanding offers of 115,800 shares between Frw 124-136 and no bids. On CTL counter, there were outstanding offers of 8,500 shares at Frw 73 and outstanding bids of 158,000 shares between Frw 65-72. On IMR counter, there were outstanding offers of 320,500 shares between Frw 45-47 and no bids. On CMR counter, there were outstanding offers of 100,000 shares at Frw 120 and no bids.

On bonds market, there was no offer and no bids

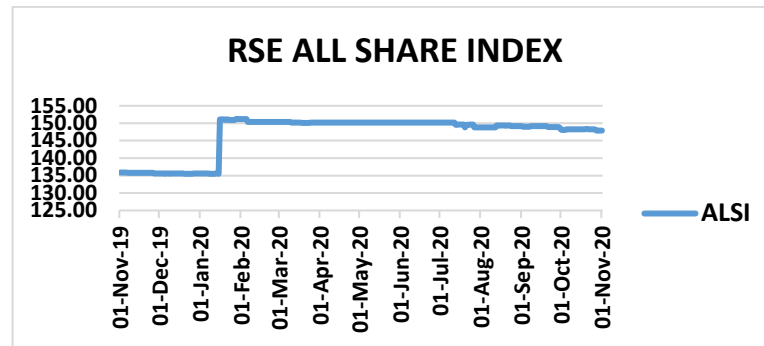
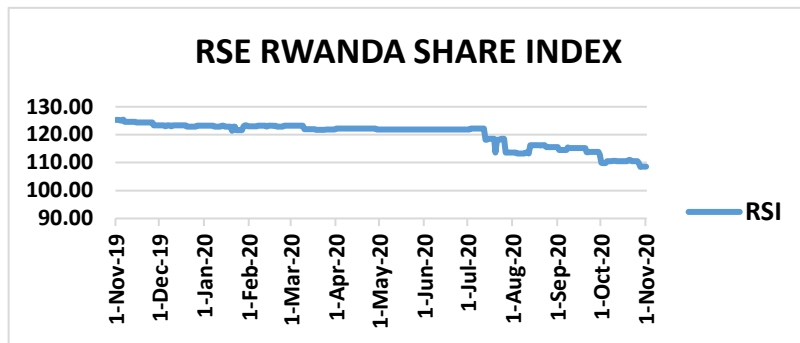
