



RWANDA STOCK EXCHANGE MARKET REPORT FOR TUESDAY 18TH OCTOBER 2022

1. Market overview

- The trading session recorded a turnover of Frw 17,355,000 worth of bonds traded in 4 deals on the fixed income market and Frw 1,717,000 from 10,100 BLR shares traded in 3 deals on the equities market.
- RSI and ALSI remained constant to close at 109.61 and 147.59 respectively.
- BLR counter closed at Frw 170 (Frw 170 previous). The trading session recorded a total turnover of Frw 1,717,000 from 10,100 shares traded in 3 deals.
- Equities counters closed as follows: BOK: Frw 272; IMR: Frw 43; CMR: Frw 120; MTNR: Frw 176; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

2. Closing bell

At the end of the formal trading hours; On the BOK counter, there were outstanding offers of 64,000 shares between Frw 272 - 280 and an outstanding bid of 39,900 shares at Frw 262. On MTNR counter, there were outstanding offers of 1,320,400 shares between Frw 176 - 180 and no bids. On BLR counter, there was an outstanding bid of 900 shares at Frw 170 and no offers. On IMR counter, there were outstanding offers of 227,000 shares between Frw 43 - 45 and no bids. On CMR counter, there were outstanding offers of 104,700 shares at Frw 120 and no bids.

On the bonds market, there were no offers and no bids.

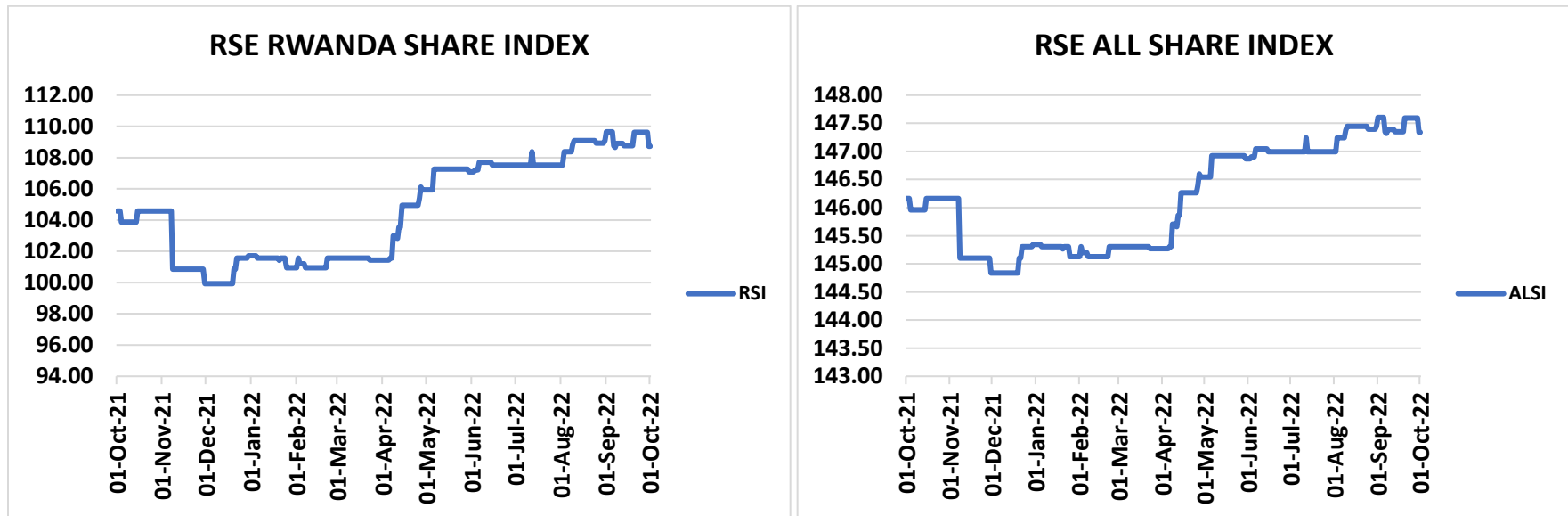
