



RWANDA STOCK EXCHANGE MARKET REPORT FOR TUESDAY 19TH JULY 2022

1. Market overview

- Today's trading session recorded a turnover of Frw 230,617,000 worth of bonds traded in 5 deals on the fixed income market and Frw 10,660,800 from 73,100 shares traded in 6 deals.
- RSI and ALSI remained constant to close at 107.51 and 146.99 respectively.
- IMR counter closed at Frw 43 (Frw 43 previous). The trading session recorded a total turnover of Frw 146,200 from 3,400 shares traded in 1 deal.
- BLR counter closed at Frw 160 (Frw 160 previous). The trading session recorded a total turnover of Frw 10,373,000 from 68,900 shares traded in 4 deals.
- MTNR counter closed at Frw 177 (Frw 177 previous). The trading session recorded a total turnover of Frw 141,600 from 800 shares traded in 1 deal.

- Equities counters closed as follows: BOK; Frw 265; CMR: Frw 120; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

2. Closing bell

At the end of the formal trading hours; On the BOK counter, there was an outstanding offer of 479,500 shares at Frw 272 and an outstanding bid of 500 shares at Frw 265. On MTNR counter, there were outstanding offers of 1,206,300 shares between Frw 177-180 and no bids. On BLR counter, there were outstanding offers of 150,000 shares between Frw 160–176 and no bids. On IMR counter, there were outstanding offers of 275,300 shares between Frw 43-45 and no bids. On CMR counter, there were outstanding offers of 112,000 shares at Frw 120 and no bids.

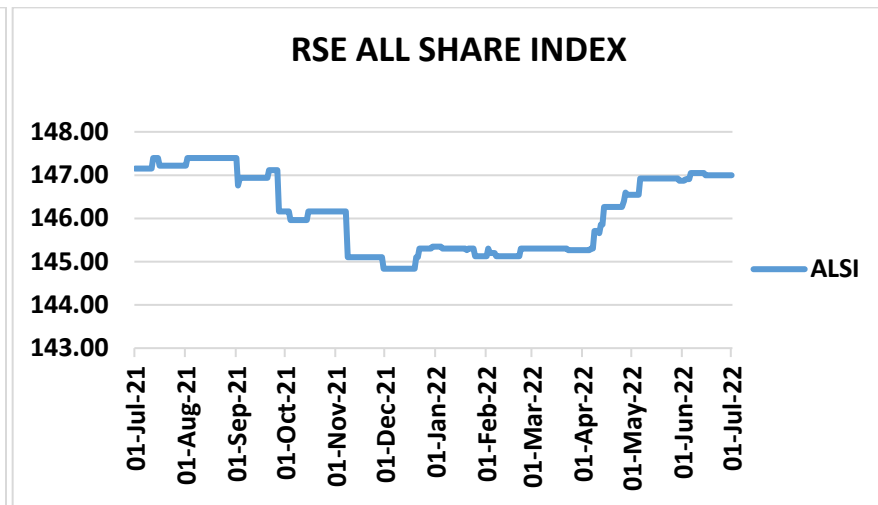
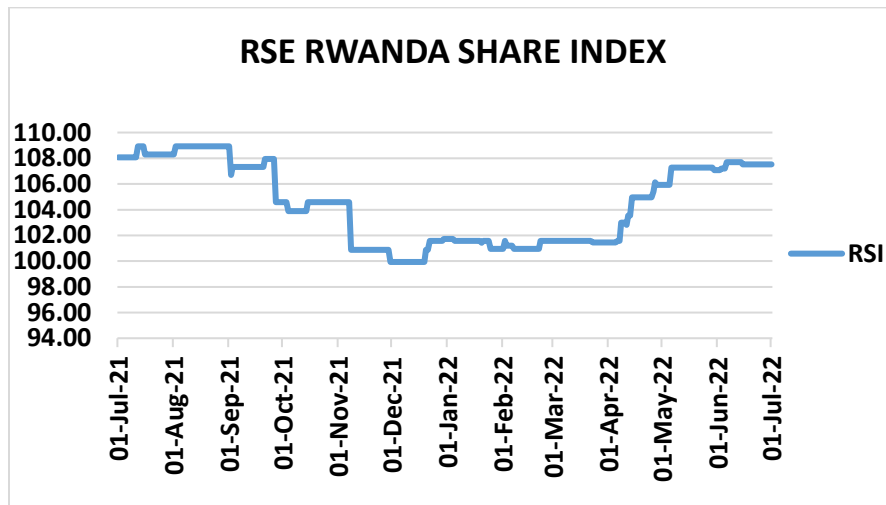
