



RWANDA STOCK EXCHANGE MARKET REPORT FOR TUESDAY 20TH OCTOBER, 2020

1. Market overview

- Today's trading session recorded on the equities market Frw 285,800 from 1,400 shares traded in 3 deals with IMR increasing 2 points to Frw 47 while the fixed income market recorded Frw 195,452,000 worth of bonds traded in 2 deals.
- RSI and ALSI went up 0.45 and 0.08 points to close at 111.07 and 148.37 respectively.
- IMR counter closed at Frw 47 (Frw 45 previous). The trading session recorded a total turnover of Frw 4,700 from 100 shares traded in 1 deal.
- BOK counter closed at Frw 233 (Frw 233 previous). The trading session recorded a total turnover of Frw 256,300 from 1,100 shares traded in 1 deal.
- BLR counter closed at Frw 124 (Frw 124 previous). The trading session recorded a total turnover of Frw 24,800 from 200 shares traded in 1 deal.
- Equities counters closed as follows: CTL: Frw 70; CMR: Frw 120; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526.

2. Closing bell

At the end of the formal trading hours, on BOK counter, there were outstanding offers of 96,200 shares between Frw 230-240 and no bids. On BLR counter, there were outstanding offers of 156,500 shares between Frw 122-136 and no bids. On CTL counter, there were outstanding offers of 96,800 shares between Frw 70-75 and no bids. On IMR counter, there were outstanding offers of 19,000 shares at Frw 45 and no bids. On CMR counter, there was an outstanding offer of 100,000 shares at Frw 120 and no bids.

On bonds market, there was no offer and no bids

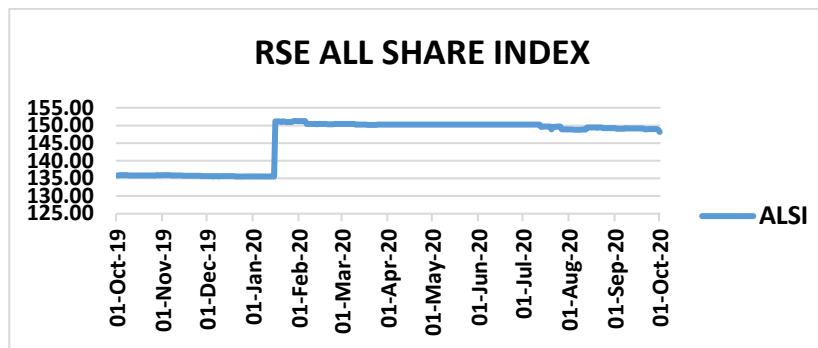
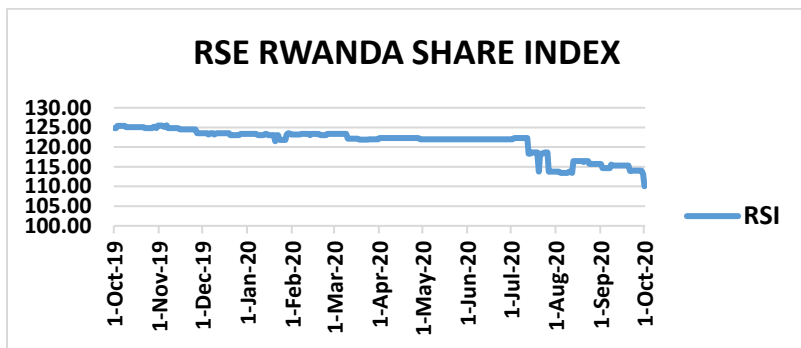
