



RWANDA STOCK EXCHANGE MARKET REPORT FOR TUESDAY 20TH SEPTEMBER 2022

1. Market overview

- The trading session recorded a turnover of Frw 3,034,800 worth of bonds traded in 1 deal on the fixed income market and Frw 927,800 from 12,100 shares traded in 9 deals on the equities market.
- RSI and ALSI went up by 0.84 and 0.24 points to close at 109.61 and 147.59 respectively.
- MTNR counter closed at Frw 176 (Frw 176 previous). The trading session recorded a total turnover of Frw 88,000 from 500 shares traded in 1 deal.
- BOK counter closed at Frw 272 (Frw 272 previous). The trading session recorded a total turnover of Frw 326,400 from 1,200 shares traded in 2 deals.
- IMR counter closed at Frw 43 (Frw 43 previous). The trading session recorded a total turnover of Frw 421,400 from 9,800 shares traded in 4 deals.
- BLR counter closed at Frw 170 (Frw 164 previous). The trading session recorded a total turnover of Frw 68,000 from 400 shares traded in 1 deal.
- CMR counter closed at Frw 120 (Frw 120 previous). The trading session recorded a total turnover of Frw 24,000 from 200 shares traded in 1 deal.
- Equities counters closed as follows: EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

2. Closing bell

At the end of the formal trading hours; On the BOK counter, there were outstanding offers of 375,700 shares between Frw 272 - 290 and an outstanding bid of 1,000 shares at Frw 265. On MTNR counter, there were outstanding offers of 1,305,200 shares between Frw 176 - 180 and no bids. On BLR counter, there was an outstanding offer of 1,000 shares at Frw 170 and an outstanding bid of 3,000 shares at Frw 160. On IMR counter, there were outstanding offers of 170,000 shares between Frw 43 - 45 and no bids. On CMR counter, there were outstanding offers of 101,500 shares at Frw 120 and no bids.

On the bonds market, there were no offers and no bids.

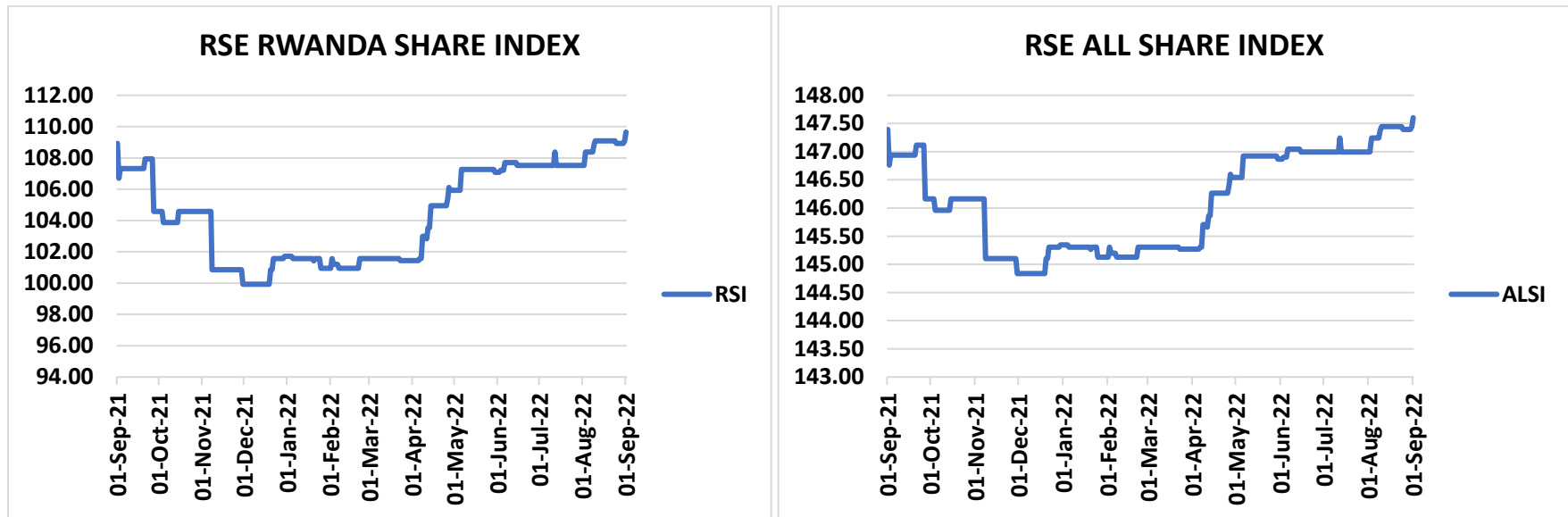
