



## RWANDA STOCK EXCHANGE MARKET REPORT FOR TUESDAY 21<sup>ST</sup> JANUARY, 2020

### 1. Market overview

- Both RSI and ALSI went up 1.49 and 0.23 points to close at 123.02 and 151.17 respectively.
- Today's trading session recorded a total of Frw 8,604,400 from 44,600 shares traded in 5 deals.
- BOK counter closed at Frw 265 (Frw 259 previous). The trading session recorded a total turnover of Frw 7,609,900 from 29,300 shares traded in 4 deals.
- CTL counter closed at Frw 65 (Frw 65 previous). The trading session recorded a total turnover of Frw 994,500 from 15,300 shares traded in 1 deal.
- Equities counters closed as follows: BLR: Frw 139; IMR: Frw 90; EQTY: Frw 445; KCB: Frw 370; NMG: Frw 1200 and USL: Frw 104.

### 2. Closing bell

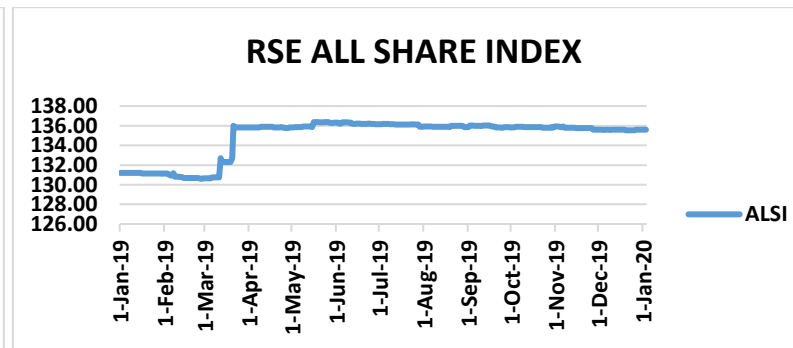
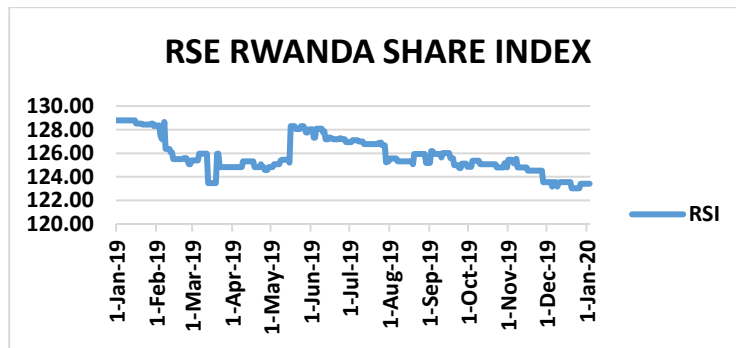
