



RWANDA STOCK EXCHANGE MARKET REPORT FOR TUESDAY 22ND FEBRUARY 2022

“Today two Government bonds were listed on Rwanda Stock Exchange”

1. Market overview

- Today's highlight was the official listing of a 5-year government bond and a 10-year government bond re-opened with a coupon rate of 11% and 12% and a yield to maturity of 11% and 11.99% respectively.
- The trading session recorded a total turnover of Frw 165,000 from 800 shares traded in 2 deals on the equities market while the fixed income market remained quiet.
- RSI and ALSI went up by 0.62 and 0.17 points to close at 101.57 and 145.30 respectively.
- MTNR counter closed at Frw 180 (Frw 180 previous). The trading session recorded a total turnover of Frw 90,000 from 500 shares traded in 1 deal.
- BOK counter closed at Frw 250 (Frw 245 previous). The trading session recorded a total turnover of Frw 75,000 from 300 shares traded in 1 deal.

- Equities counters closed as follows: BLR: Frw 125; IMR: Frw 45; CMR: Frw 120; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

2. Closing bell

At the end of the formal trading hours; On the BOK counter, there were outstanding offers of 19,500 shares at Frw 250 and no bids. On MTNR counter, there were outstanding offers of 750,000 shares at Frw 180 and no bids. On BLR counter, there were outstanding offers of 109,000 shares at Frw 125 and no bids. On IMR counter, there were outstanding offers of 572,200 shares at Frw 45 and no bids. On CMR counter, there was an outstanding offer of 100,000 shares at Frw 120 and no bids.

On the bonds market; there was no outstanding offer and no bids.

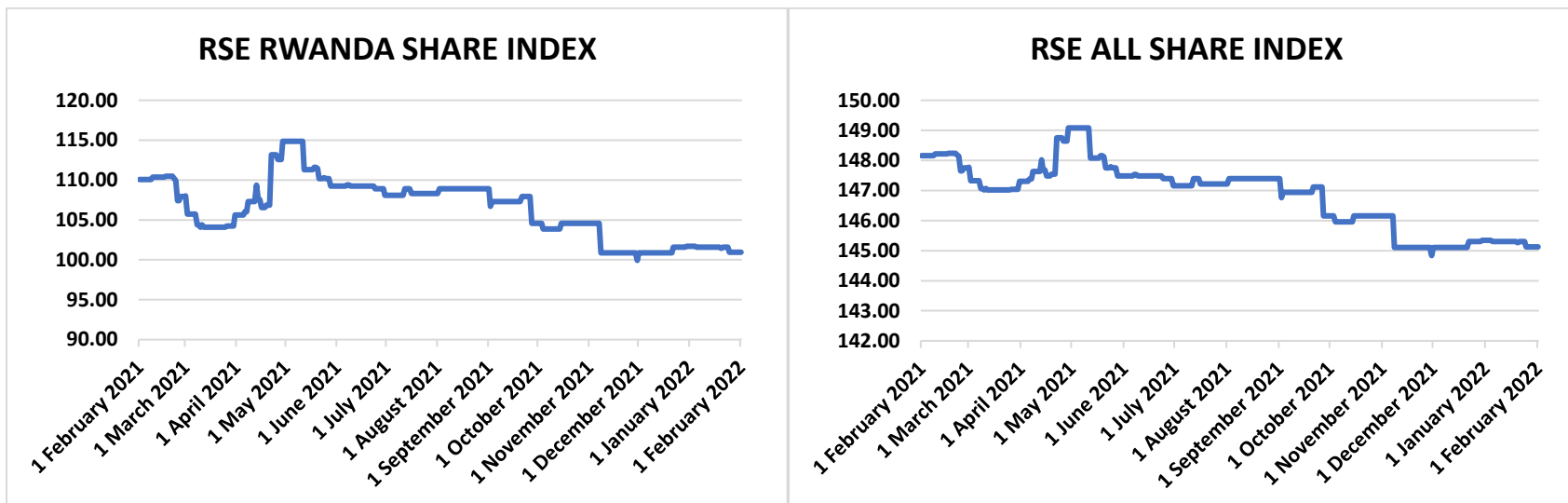
