



RWANDA STOCK EXCHANGE MARKET REPORT FOR TUESDAY 23RD JANUARY 2024

1. Market overview

- Today's trading session recorded a turnover of Frw 384,604,141 worth of bonds traded in 5 deals on the fixed-income market and Frw 4,130,000 from 14,000 BOK shares traded in 1 deal on the equities market.
- RSI and ALSI remained constant to close at 112.85 and 143.66 respectively.
- BOK counter closed at Frw 295 (Frw 295 previous). The trading session recorded a total turnover of Frw 4,130,000 from 14,000 shares traded in 1 deal.
- Equities counters closed as follows: BLR: Frw 172; IMR: Frw 43; MTNR: Frw 170; CMR: Frw 132; EQTY: Frw 440; KCB: Frw 328; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

• 2. Closing bell

At the end of the formal trading hours; On MTNR counter, there were outstanding offers of 779,300 shares between Frw 170 - 176 and no bids. On IMR counter, there were outstanding offers of 300,100 shares between Frw 43 - 45 and no bids. On BLR counter, there were outstanding offers of 365,000 shares between Frw 172 - 175 and no bids. On CMR counter, there were outstanding bids of 10,700 shares at Frw 132 and no offers. On BOK counter, there were outstanding bids of 10,000 shares between Frw 275 - 295 and outstanding offers of 8,200 at Frw 300.

On the bonds market, there were no outstanding bids and no outstanding offers.

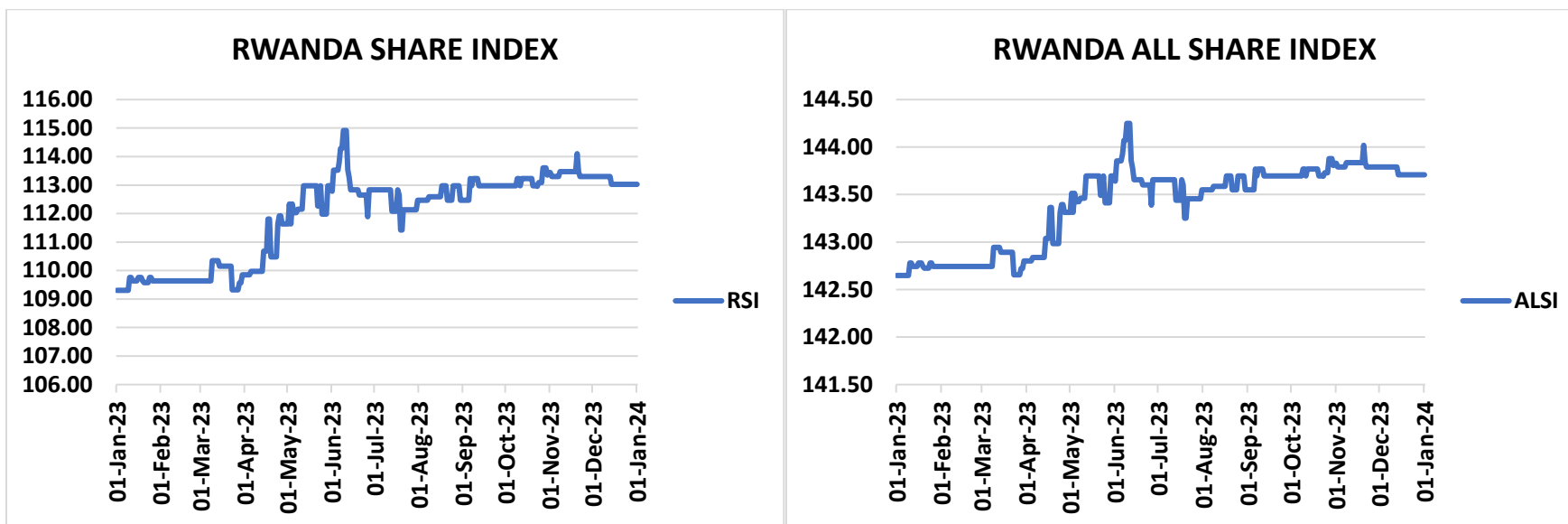
