



RWANDA STOCK EXCHANGE MARKET REPORT FOR TUESDAY 24TH AUGUST 2021

“Today a 20-year Government bond was listed on Rwanda Stock Exchange at a coupon rate of 13.00%”

1. Market overview

- Today’s highlight was the listing of a 20-year government bond with a face value of Frw 25 billion at a coupon rate of 13.00%. The trading session recorded a turnover of Frw 8,711,310 worth of bonds traded in 5 deals on the fixed income market and Frw 1,182,000 from 11,900 shares traded in 6 deals on the equities market.
- RSI and ALSI remained constant to close at 108.92 and 147.39 respectively.
- MTNR counter closed at Frw 230 (Frw 230 previous). The trading session recorded a total turnover of Frw 207,000 from 900 shares traded in 2 deals.
- IMR counter closed at Frw 45 (Frw 45 previous). The trading session recorded a total turnover of Frw 207,000 from 4,600 shares traded in 2 deals.
- BLR counter closed at Frw 120 (Frw 120 previous). The trading session recorded a total turnover of Frw 768,000 from 6,400 shares traded in 2 deals.

- Equities counters closed as follows: BOK: Frw 240; CMR: Frw 120; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

2. Closing bell

At the end of the formal trading hours; on BOK counter, there were outstanding offers of 39,000 shares between Frw 240-242 and no bids. On MTNR counter, there were outstanding offers 988,900 shares between Frw 230-250 and no bids. On BLR counter, there were outstanding offers of 88,500 shares between Frw 120-125 and no bids. On CMR counter, there was an outstanding offer of 100,000 shares at Frw 120 and no bids. On IMR counter, there were outstanding offers of 780,000 shares between Frw 45-47 and no bids.

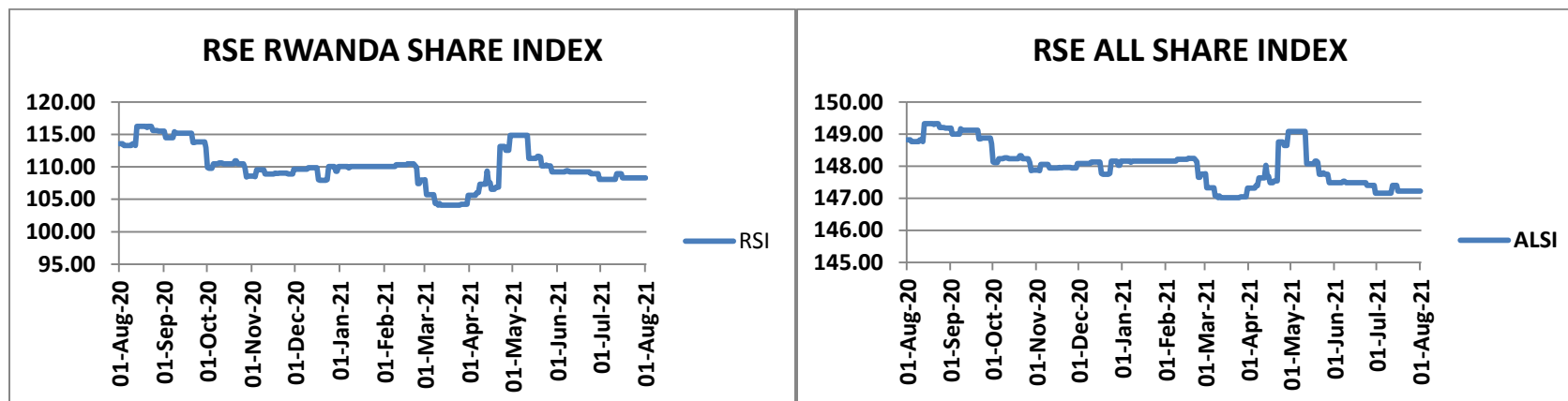
