2. Closing bell

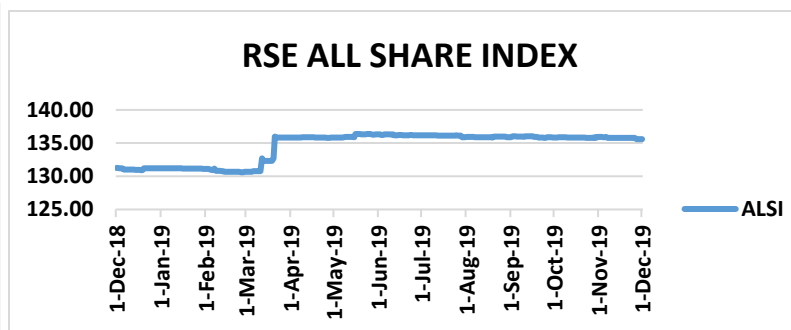
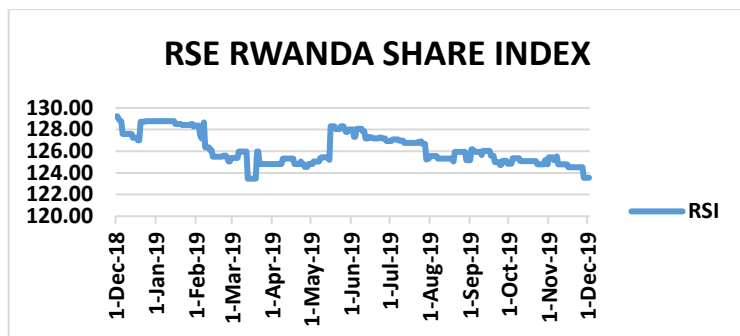
