



RWANDA STOCK EXCHANGE MARKET REPORT FOR TUESDAY 24TH NOVEMBER 2020

“Today a 7 year Government bond was officially listed on Rwanda Stock Exchange at a coupon rate of 11.435%”

1. Market overview

- Today's highlight was the official listing of the T-bond N° FXD7/2020/7YRS on the Rwanda Stock Exchange with a face value of Frw 20 billion at a coupon rate of 11.435%. The trading session recorded on the fixed income market a total of Frw 310,302,000 worth of bonds traded in 2 deals while the equities market was quiet.
- RSI and ALSI remained constant to close at 109.04 and 147.96 respectively.
- Equities counters closed as follows: CMR: Frw 120; CTL: Frw 72; IMR: Frw 45; BOK: Frw 230; BLR: Frw 120; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526.

2. Closing bell

At the end of the formal trading hours, on BOK counter, there were outstanding offers of 170,900 shares between Frw 230-240 and no bids. On BLR counter, there were outstanding offers of 155,000 shares between Frw 122-136 and no bids. On CTL counter, there were outstanding offers of 32,900 shares between Frw 72-73 and outstanding bids of 30,200 shares between Frw 65-70. On IMR counter, there were outstanding offers of 315,300 shares between Frw 45-47 and no bids. On CMR counter, there was an outstanding offer of 100,000 shares at Frw 120 and no bids.

On bonds market, there was no offer and no bids

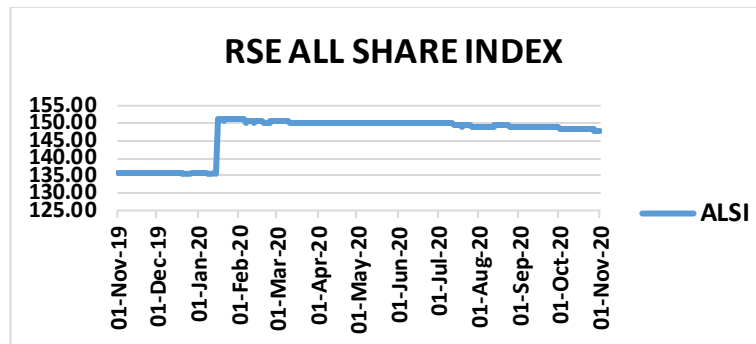
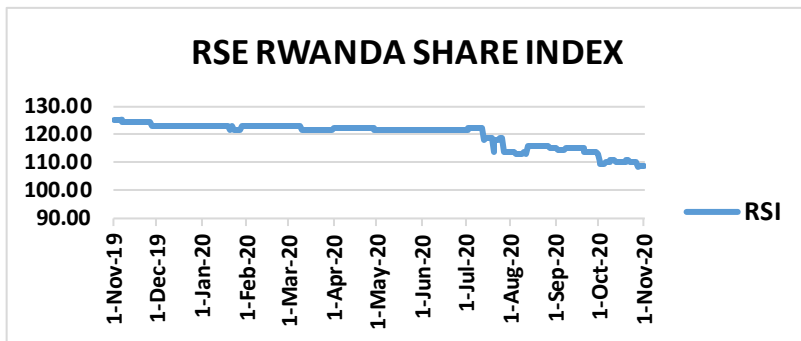
