



## RWANDA STOCK EXCHANGE MARKET REPORT FOR TUESDAY 25<sup>TH</sup> AUGUST 2020

*“Today two Government bonds were listed on Rwanda Stock Exchange at a coupon rate of 11.145% and 13.150%”*

### 1. Market overview

- Today's highlight was the listing of a 5 years government bond with a face value of Frw 15 billion at a coupon rate of 11.145% and a 20 years government bond with a face value of Frw 20 billion at a coupon rate of 13.150%.
- RSI and ALSI remained constant to close at 115.74 and 149.24 respectively.
- The market recorded a total of Frw 3,224,600 from 44,200 shares traded in 4 deals and Frw 50,180,000 worth of bonds traded in 1 deal.
- CTL counter closed at Frw 73 (Frw 73 previous). The trading session recorded a total turnover of Frw 3,224,600 from 44,200 shares traded in 4 deals.
- Equities counters closed as follows: CMR: Frw 120; IMR: Frw 47; BLR: Frw 137; CTL: Frw 73; BOK: Frw 240; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526.

### 2. Closing bell

At the end of the formal trading hours, on BOK counter, there were outstanding offers of 269,100 shares between Frw 235-260 and no bids. On BLR counter, there were outstanding offers of 999,500 shares between Frw 137-145 and an outstanding bid of 3,000 shares at Frw 125. On CTL counter, there was an outstanding offer of 6,000 shares at Frw 75 and no bids. On IMR counter, there were outstanding offers of 44,600 shares between Frw 47-50 and no bids. On CMR counter, there was an outstanding offer of 100,000 shares at Frw 120 and no bids.

On bonds market, there were no bids and no offers.

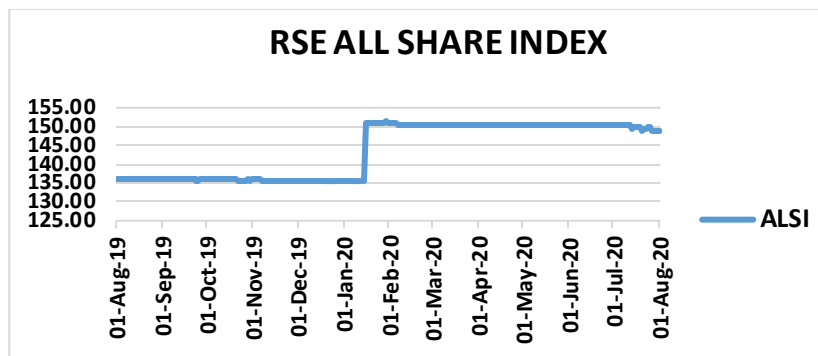
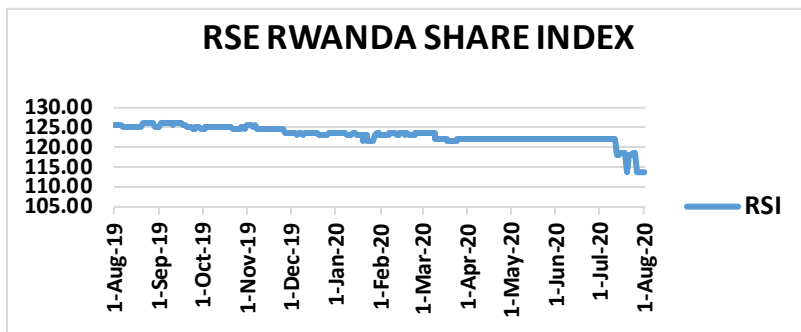

## 6. CORPORATE NEWS

- **Given the significant uncertainties on the extent and duration of the disruption as a result of the COVID-19 outbreak, BRALIRWA Plc. Board of Directors have taken steps to protect the company cash flow to preserve liquidity in the interest of the company, and as such proposed not to pay out any dividend on the 2019 result. This proposal will also be subject to approval during the upcoming Annual General Meeting of shareholders to be held on 17<sup>th</sup> September 2020 at 2:30pm by Teleconference (Online).**
- **The Directors of Nation Media Group Plc didn't recommend payment of a final dividend and recommended, subject to approval by the CMA, the Nairobi Securities Exchange Plc and the shareholders at the Annual General Meeting, a bonus share issue of one new fully paid ordinary share for every ten shares held in the capital of the Company, to the shareholders on the register of members at the close of business on 12<sup>th</sup> June, 2020. The new shares shall not qualify for payment of any dividend for the year 2019.**
