



## RWANDA STOCK EXCHANGE MARKET REPORT FOR TUESDAY 29<sup>TH</sup> DECEMBER 2020

*“Today a re-opened Government bond was listed on Rwanda Stock Exchange at a coupon rate of 13.150%”*

### 1. Market overview

- Today's highlight was the official listing of the re-opened T-bond No FXD6/2020/20yrs on the Rwanda Stock Exchange at a coupon rate of 13.150% and a yield to maturity of 13.100%. The trading session recorded on the equities market Frw 76,644,200 from 1,772,400 shares traded in 3 deals while the fixed income market was quiet.
- RSI and ALSI went down 0.71 and 0.13 points to close at 109.34 and 148.02 respectively.
- BOK counter closed at Frw 233 (Frw 233 previous). The trading session recorded a total turnover of Frw 279,600 from 1,200 shares traded in 1 deal.
- CTL counter closed at Frw 72 (Frw 75 previous). The trading session recorded a total turnover of Frw 504,000 from 7,000 shares traded in 1 deal.
- IMR counter closed at Frw 43 (Frw 45 previous). The trading session recorded a total turnover of Frw 75,860,000 from 1,764,200 shares traded in 1 deal.
- Equities counters closed as follows: BLR: Frw 121; CMR: Frw 120; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526.

### 2. Closing bell

At the end of the formal trading hours, on BOK counter, there were outstanding offers of 184,500 shares between Frw 227-240 and no bids. On BLR counter, there were outstanding offers of 155,000 shares between Frw 120-136 and no bids. On CTL counter, there was an outstanding offer of 2,500 shares at Frw 75 and outstanding bids of 116,200 shares between Frw 67-72. On IMR counter, there were outstanding offers of 74,300 shares at Frw 45 and no bids. On CMR counter, there was an outstanding offer of 100,000 shares at Frw 120 and no bids.

On bonds market, there was no offer and no bids

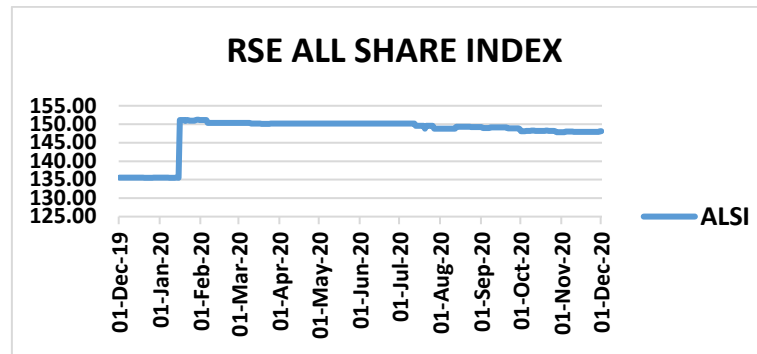
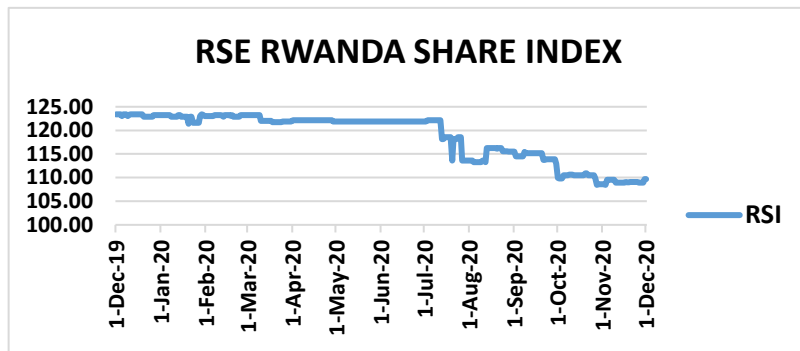
