



RWANDA STOCK EXCHANGE MARKET REPORT FOR TUESDAY 29TH NOVEMBER 2022

1. Market overview

- The trading session recorded a total turnover of Frw 25,748,400 worth of bonds traded in 7 deals on the fixed income market while the equities market remained quiet.
- RSI and ALSI remained constant to close at 108.80 and 147.35 respectively.
- Equities counters closed as follows: BLR: Frw 166; BOK: Frw 270; IMR: Frw 43; CMR: Frw 120; MTNR: Frw 176; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

2. Closing bell

At the end of the formal trading hours; On the BOK counter, there were outstanding offers of 85,100 shares between Frw 272 - 280 and no bids. On MTNR counter, there were outstanding offers of 1,218,500 shares between Frw 176 - 180 and no bids. On BLR counter, there was an outstanding bid of 1,100 shares at Frw 170 and no offers. On IMR counter, there were outstanding offers of 257,600 shares between Frw 43 - 45 and no bids. On CMR counter, there was an outstanding offer of 100,000 shares at Frw 120 and no bids.

On the bonds market, there was an outstanding bid of Frw 30,200,000 worth of bonds at Frw 100.5 and no offers.

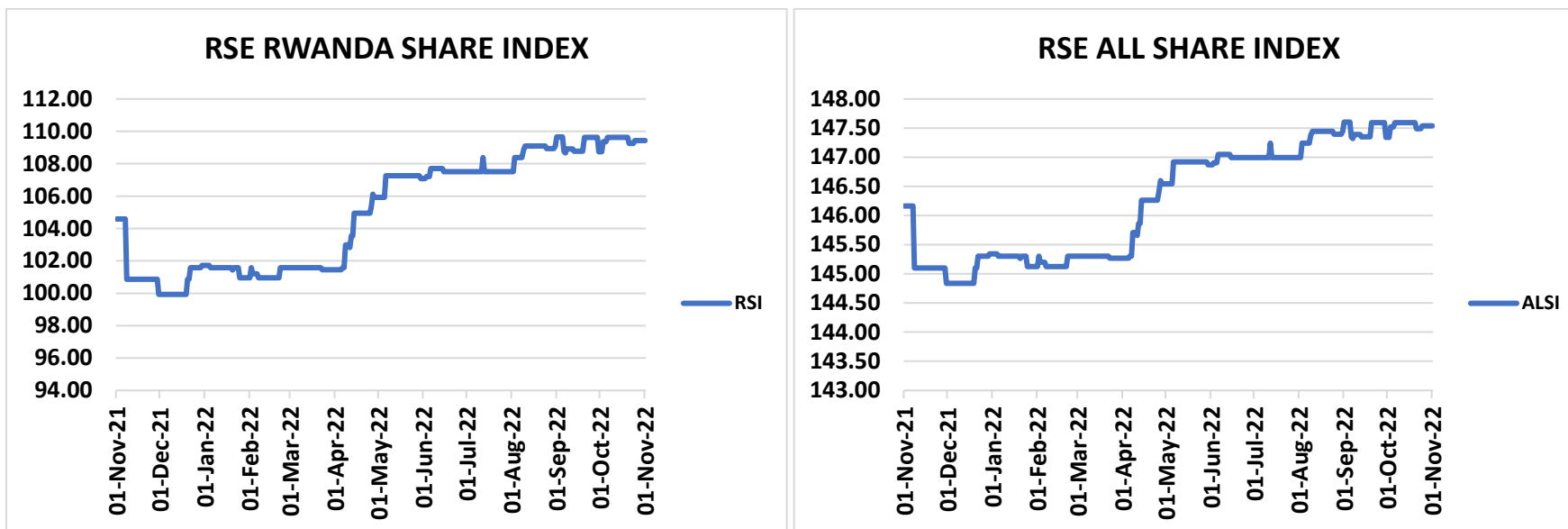
