



## RWANDA STOCK EXCHANGE MARKET REPORT FOR TUESDAY 30<sup>TH</sup> AUGUST 2022

### 1. Market overview

- The trading session recorded a turnover of Frw 778,639,700 worth of bonds traded in 9 deals on the fixed income market and Frw 2,509,000 from 15,000 shares traded in 4 deals on the equities market.
- RSI and ALSI remained constant to close at 108.93 and 147.39 respectively.
- BOK counter closed at Frw 272 (Frw 272 previous). The trading session recorded a total turnover of Frw 544,000 from 2,000 shares traded in 1 deal.
- BLR counter closed at Frw 165 (Frw 165 previous). The trading session recorded a total turnover of Frw 1,485,000 from 9,000 shares traded in 2 deals.
- CMR counter closed at Frw 120 (Frw 120 previous). The trading session recorded a total turnover of Frw 480,000 from 4,000 shares traded in 1 deal.
- Equities counters closed as follows: IMR: Frw 42; MTNR: Frw 177; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

### 2. Closing bell

At the end of the formal trading hours; On the BOK counter, there were outstanding offers of 373,100 shares between Frw 272 - 290 and an outstanding bid of 22,000 shares between Frw 245 - 247. On MTNR counter, there were outstanding offers of 910,300 shares between Frw 177 - 180 and no bids. On BLR counter, there were outstanding offers of 62,000 shares at Frw 165 and no bids. On IMR counter, there were outstanding offers of 32,500 shares at Frw 43 and no bids. On CMR counter, there were outstanding offers of 104,000 shares at Frw 120 and no bids.

On the bonds market, there was an outstanding offer of Frw 10,500,000 worth of bonds at Frw 102.5 and no bids.

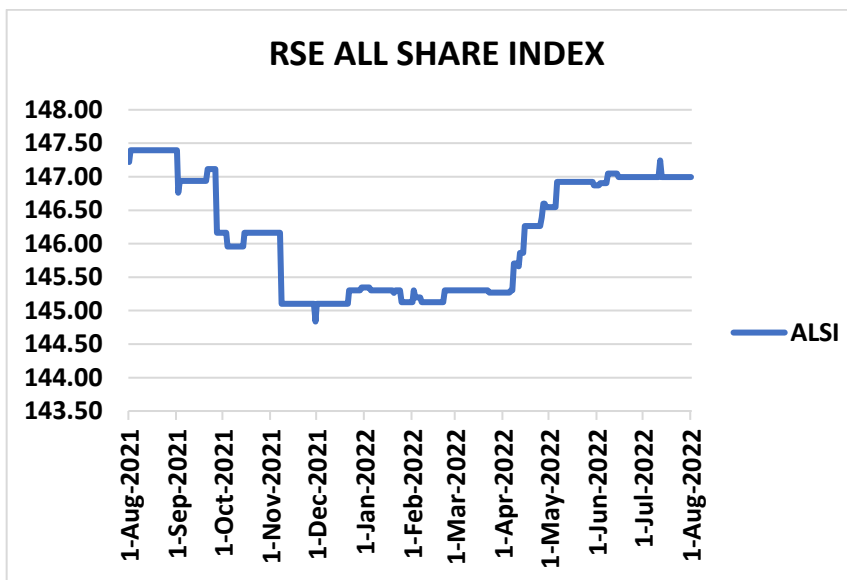
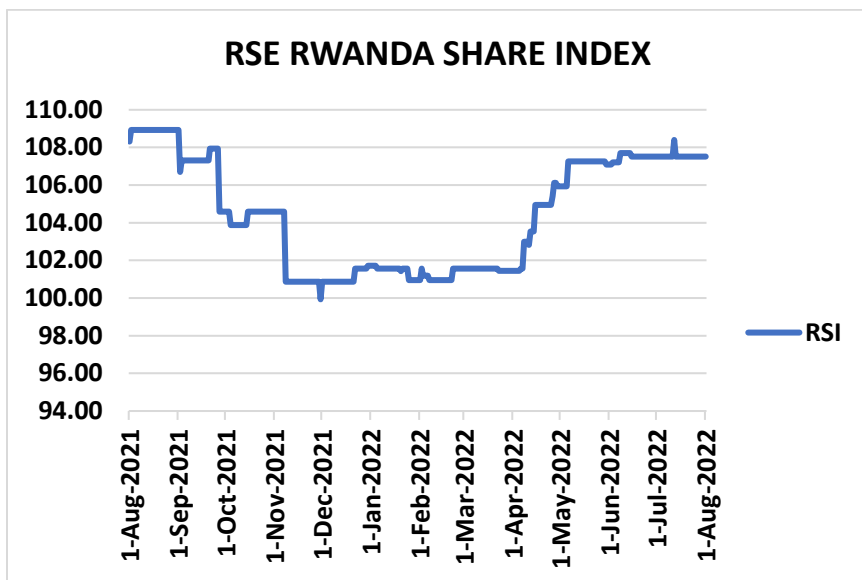
