



## RWANDA STOCK EXCHANGE MARKET REPORT FOR TUESDAY 31<sup>ST</sup> JANUARY 2023

### 1. Market overview

- The trading session recorded a total turnover of Frw 49,500 from 1,100 IMR shares traded in 1 deal on the equities market while the fixed income market remained quiet.
- RSI and ALSI remained constant to close at 109.63 and 142.74 respectively.
- IMR counter closed at Frw 45 (Frw 45 previous). The trading session recorded a total turnover of Frw 49,500 from 1,100 shares traded in 1 deal.
- Equities counters closed as follows: BLR: Frw 170; BOK: Frw 271; CMR: Frw 120; MTNR: Frw 175; EQTY: Frw 440; KCB: Frw 328; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

### 2. Closing bell

At the end of the formal trading hours; On the BOK counter, there were outstanding offers of 42,200 shares between Frw 271 - 272 and no bids. On MTNR counter, there were outstanding offers of 1,237,100 shares between Frw 175 - 180 and no bids. On BLR counter, there was an outstanding offer of 1,800 shares at Frw 170 and an outstanding bid of 50,000 shares at Frw 160. On IMR counter, there were outstanding offers of 252,900 shares at Frw 45 and no bids. On CMR counter, there were outstanding bids of 1,100 shares between Frw 120 - 122 and no offers.

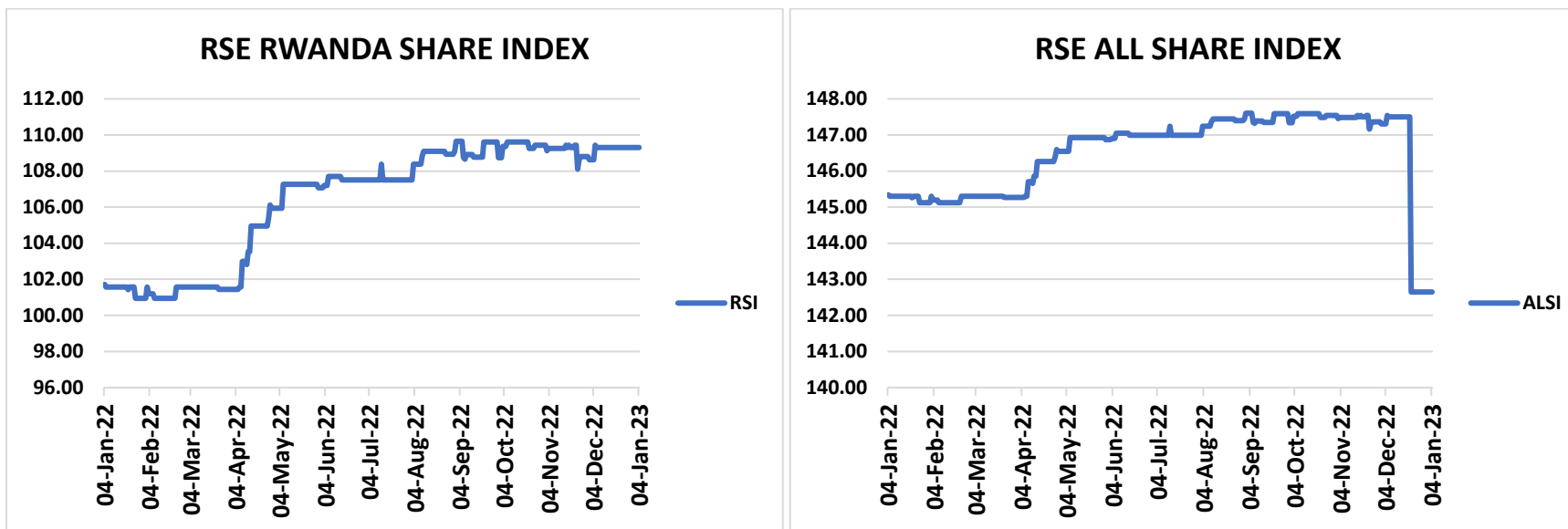
