



RWANDA STOCK EXCHANGE MARKET REPORT FOR TUESDAY 3RD OCTOBER 2023

1. Market overview

- Today's trading session recorded a total turnover of Frw 9,273,200 from 35,400 shares traded in 3 deals on the equities market and Frw 545,619,000 worth of Bonds traded in 2 deals on the fixed-income market.
- RSI and ALSI remain constant to close at 112.97 and 143.69 respectively.
- BOK counter closed at Frw 290 (Frw 290 previous). The trading session recorded a total turnover of Frw 7,803,200 from 27,000 shares traded in 2 deals.
- BLR counter closed at Frw 175 (Frw 175 previous). The trading session recorded a total turnover of Frw 1,470,000 from 8,400 shares traded in 1 deal.
- Equities counters closed as follows: BLR: Frw 175; BOK: Frw 290; IMR: Frw 45; CMR: Frw 132; MTNR: Frw 170; EQTY: Frw 440; KCB: Frw 328; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

2. Closing bell

At the end of the formal trading hours; On MTNR counter, there were outstanding offers of 459,400 shares between Frw 170-176 and no bids. On IMR counter, there were outstanding offers of 264,100 shares at Frw 45 and no bids. On BLR counter, there were outstanding offers of 93,600 shares between Rwf 175-180. On BOK counter, there was an outstanding offer of 15,400 shares at Rwf 290. On CMR counter, there were outstanding offers of 100,000 shares at Frw 132 and no bids. On EQTY counter, there was an outstanding bid of 200 shares at Frw 440 and no offer.

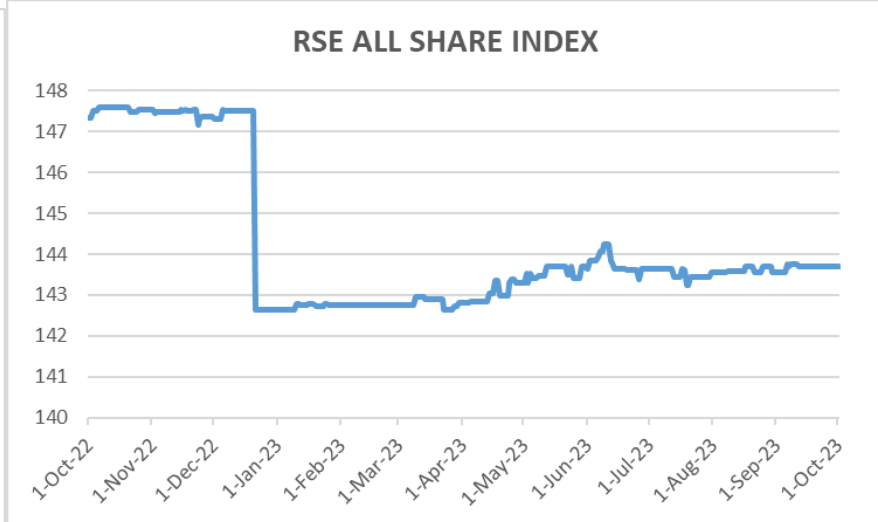
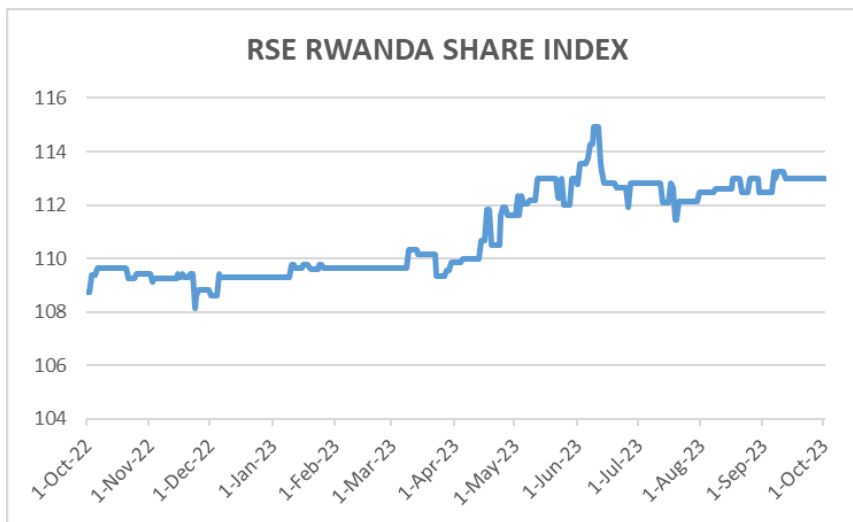
