



RWANDA STOCK EXCHANGE MARKET REPORT FOR WEDNESDAY 02ND FEBRUARY 2022

1. Market overview

- The trading session recorded a turnover of Frw 240,103,000 worth of bonds traded in 4 deals on the fixed income market and Frw 50,000 from 200 BOK shares traded in 1 deal on the equities market.
- RSI and ALSI went up by 0.62 and 0.17 points to close at 101.57 and 145.30 respectively.
- BOK counter closed at Frw 250 (Frw 245 previous). The trading session recorded a total turnover of Frw 50,000 from 200 shares traded in 1 deal.
- Equities counters closed as follows: BLR: Frw 125; IMR: Frw 45; CMR: Frw 120; MTNR: Frw 180; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

2. Closing bell

At the end of the formal trading hours; On BOK counter, there were outstanding offers of 41,200 shares at Frw 250 and no bids. On MTNR counter, there were outstanding offers of 550,000 shares at Frw 180 and no bids. On BLR counter, there were outstanding offers of 96,000 shares between Frw 125-130 and no bids. On IMR counter, there were outstanding offers of 473,900 shares at Frw 45 and no bids. On CMR counter, there were outstanding offers of 100,000 shares at Frw 120 and no bids.

On the bonds market; there was an outstanding offer of Frw 10,000,000 worth of bonds at Frw 106 and no bids.

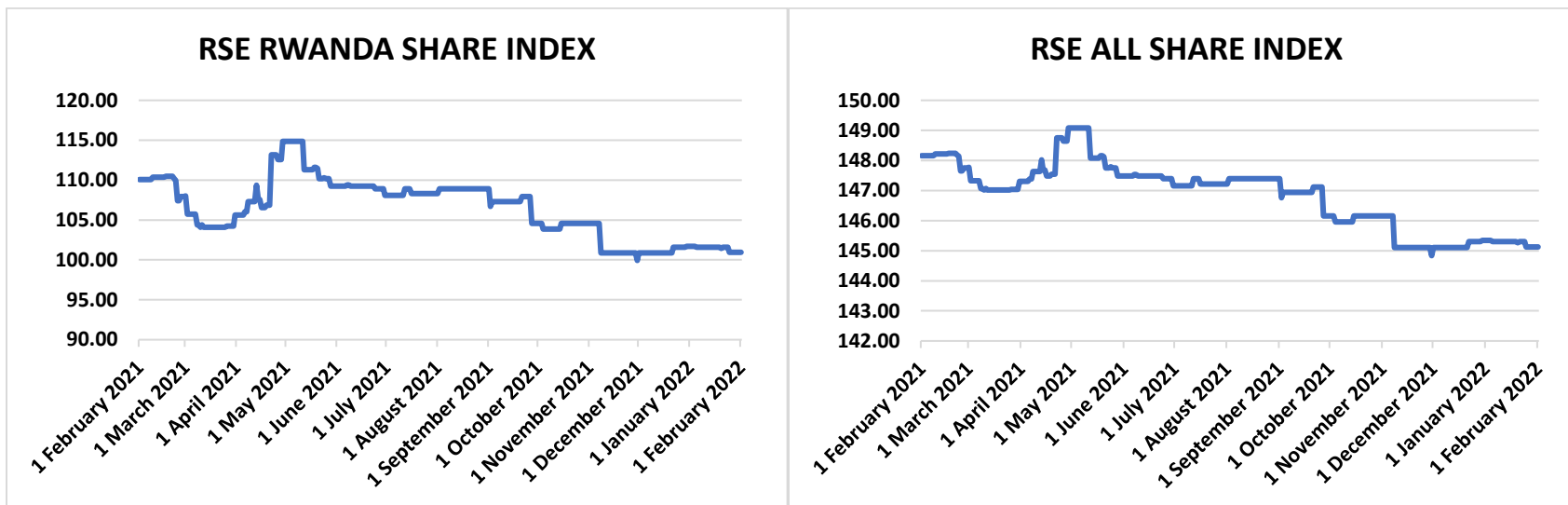
