



## RWANDA STOCK EXCHANGE MARKET REPORT FOR WEDNESDAY 04<sup>TH</sup> DECEMBER, 2019

### 1. Market overview

- Both RSI and ALSI remained constant to close at 123.54 and 135.61 respectively.
- Today's trading session recorded a total of Frw 8,716,500 from 115,300 shares traded in 8 deals and Frw 28,918,600 worth of bond traded in 3 deals.
- CTL counter closed at Frw 70 (Frw 70 previous). The trading session recorded a total turnover of Frw 7,243,500 from 109,200 shares traded in 5 deals.
- BOK counter closed at Frw 265 (Frw 265 previous). The trading session recorded a total turnover of Frw 1,325,000 from 5,000 shares traded in 1 deal.
- BLR counter closed at Frw 139 (Frw 139 previous). The trading session recorded a total turnover of Frw 139,000 from 1,000 shares traded in 1 deal.
- IMR counter closed at Frw 90 (Frw 90 previous). The trading session recorded a total turnover of Frw 9,000 from 100 shares traded in 1 deal.
- Equities counters closed as follows: KCB: Frw 370; EQTY: Frw 350; NMG: Frw 1200 and USL: Frw 104.

### 2. Closing bell

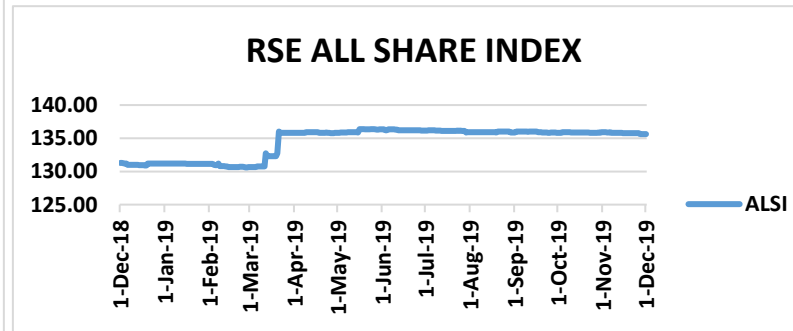
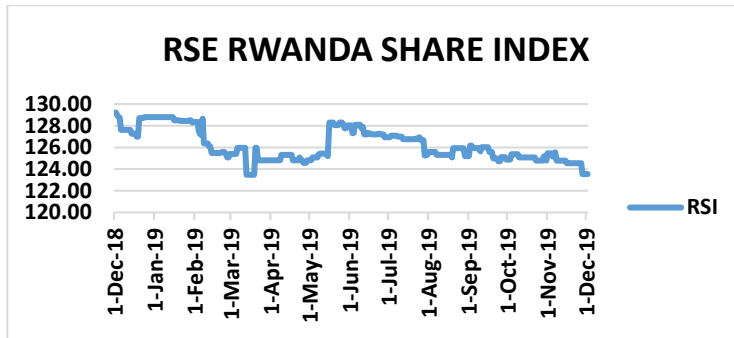
