



RWANDA STOCK EXCHANGE MARKET REPORT FOR WEDNESDAY 04TH JANUARY 2023

1. Market overview

- The trading session recorded a total turnover of Frw 2,989,744,000 worth of bonds traded in 5 deals on the fixed income market while the equities market remained quiet.
- RSI and ALSI remained constant to close at 109.30 and 142.64 respectively.
- Equities counters closed as follows: BLR: Frw 170; BOK: Frw 271; IMR: Frw 43; CMR: Frw 120; MTNR: Frw 175; EQTY: Frw 440; KCB: Frw 328; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

2. Closing bell

At the end of the formal trading hours; On the BOK counter, there was an outstanding offer of 27,200 shares at Frw 272 and an outstanding bid of 1,000 shares at Frw 271. On MTNR counter, there were outstanding offers of 1,116,800 shares between Frw 175 - 180 and no bids. On BLR counter, there were outstanding offers of 2,300 shares at Frw 170 and no bids. On IMR counter, there were outstanding offers of 156,100 shares between Frw 43 - 45 and no bids. On CMR counter, there was an outstanding bid of 2,800 shares at Frw 120 and no offers.

On the bonds market, there were no offers and no bids.

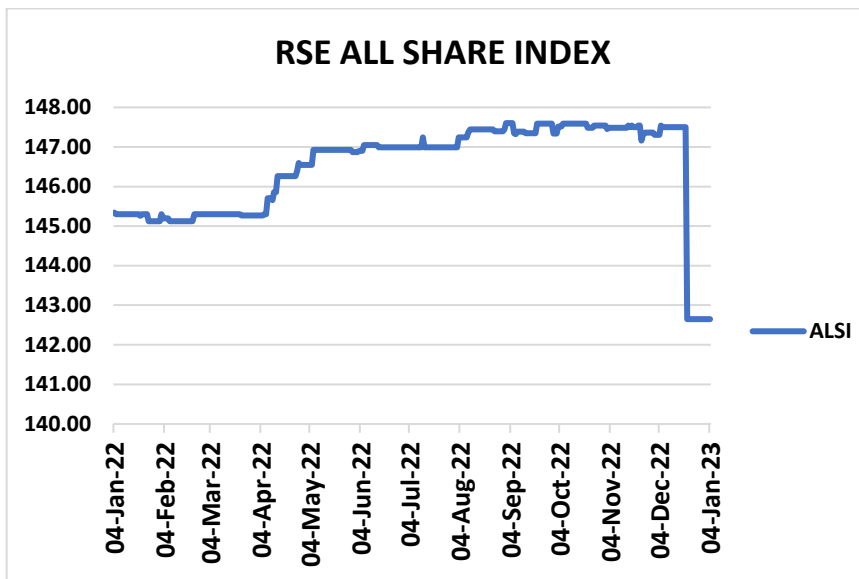
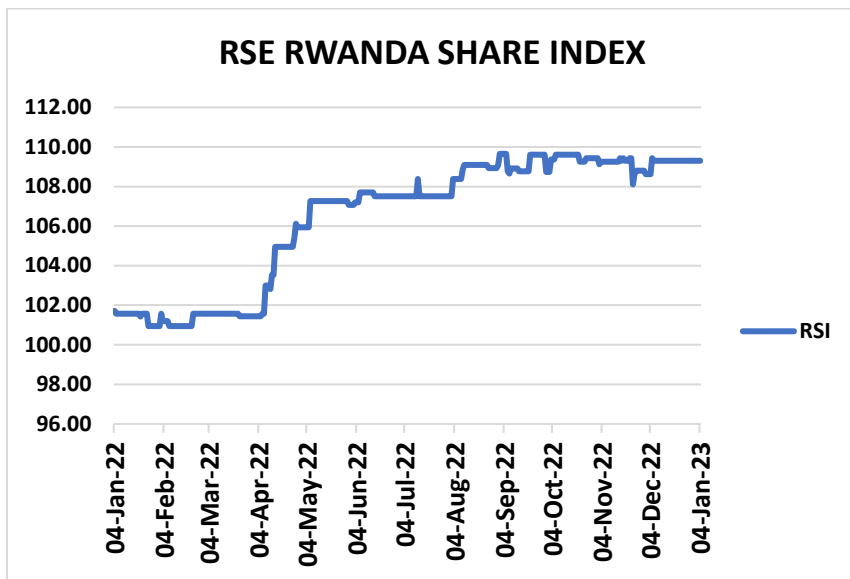
