



RWANDA STOCK EXCHANGE MARKET REPORT FOR WEDNESDAY 04TH NOVEMBER 2020

1. Market overview

- Today's trading session recorded on the fixed income market a total of Frw 36,210,000 worth of bonds traded in 3 deals while the equities market recorded Frw 1,445,300 from 9,500 shares traded in 4 deals with BLR increasing 2 points to Frw 120 and BOK increasing 3 points to Frw 233.
- RSI and ALSI went up 1.06 and 0.20 points to close at 109.52 and 148.05 respectively.
- BOK counter closed at Frw 233 (Frw 230 previous). The trading session recorded a total turnover of Frw 722,300 from 3,100 shares traded in 1 deal.
- BLR counter closed at Frw 120 (Frw 118 previous). The trading session recorded a total turnover of Frw 576,000 from 4,800 shares traded in 1 deal.
- IMR counter closed at Frw 45 (Frw 45 previous). The trading session recorded a total turnover of Frw 27,000 from 600 shares traded in 1 deal.

- CMR counter closed at Frw 120 (Frw 120 previous). The trading session recorded a total turnover of Frw 120,000 from 1,000 shares traded in 1 deal.
- Equities counters closed as follows: CTL: Frw 70; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526.

2. Closing bell

At the end of the formal trading hours, on BOK counter, there were outstanding offers of 290,200 shares between Frw 230-240 and no bids. On BLR counter, there were outstanding offers of 155,300 shares between Frw 122-136 and no bids. On CTL counter, there were outstanding offers of 78,500 shares between Frw 70-75 and an outstanding bid of 30,000 shares at Frw 65. On IMR counter, there were outstanding offers of 86,900 shares between Frw 45-47 and no bids. On CMR counter, there was an outstanding offer of 100,000 shares at Frw 120 and no bids.

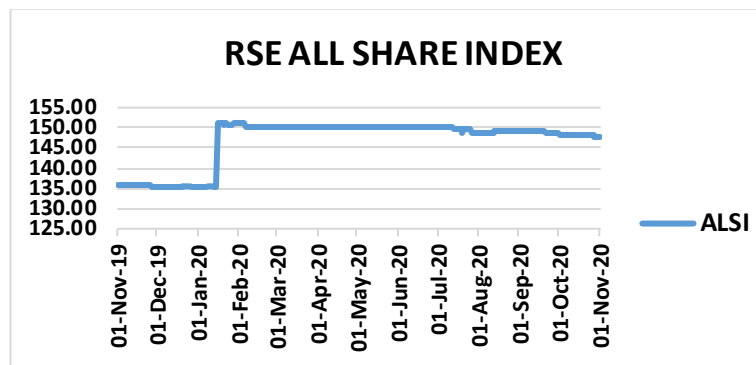
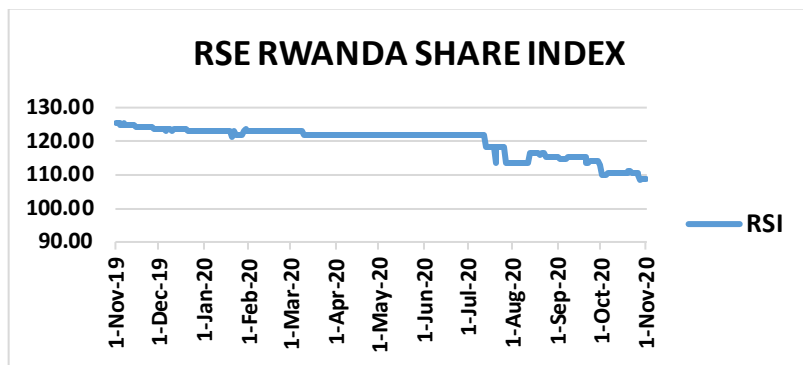
