



## RWANDA STOCK EXCHANGE MARKET REPORT FOR WEDNESDAY 05<sup>TH</sup> OCTOBER 2022

### 1. Market overview

- The trading session recorded a turnover of Frw 504,699,300 from 3,159,100 shares traded in 9 deals on the equities market and Frw 4,898,260 worth of bonds traded in 3 deals on the fixed income market.
- RSI and ALSI remained constant to close at 109.36 and 147.52 respectively.
- MTNR counter closed at Frw 176 (Frw 176 previous). The trading session recorded a total turnover of Frw 15,105,600 from 94,200 shares traded in 4 deals.
- BLR counter closed at Frw 170 (Frw 170 previous). The trading session recorded a total turnover of Frw 489,297,000 from 3,058,000 shares traded in 3 deals.
- IMR counter closed at Frw 43 (Frw 43 previous). The trading session recorded a total turnover of Frw 296,700 from 6,900 shares traded in 2 deals.

- Equities counters closed as follows: BOK: Frw 270; CMR: Frw 120; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

### 2. Closing bell

At the end of the formal trading hours; On the BOK counter, there was an outstanding offer of 50,000 shares at Frw 280 and outstanding bids of 900 shares at Frw 272. On MTNR counter, there were outstanding offers of 1,133,400 shares between Frw 176 - 180 and no bids. On BLR counter, there was an outstanding offer of 9,700 shares at Frw 170 and no bids. On IMR counter, there were outstanding offers of 196,600 shares between Frw 43 - 45 and no bids. On CMR counter, there were outstanding offers of 105,700 shares at Frw 120 and no bids.

On the bonds market, there were no offers and no bids.

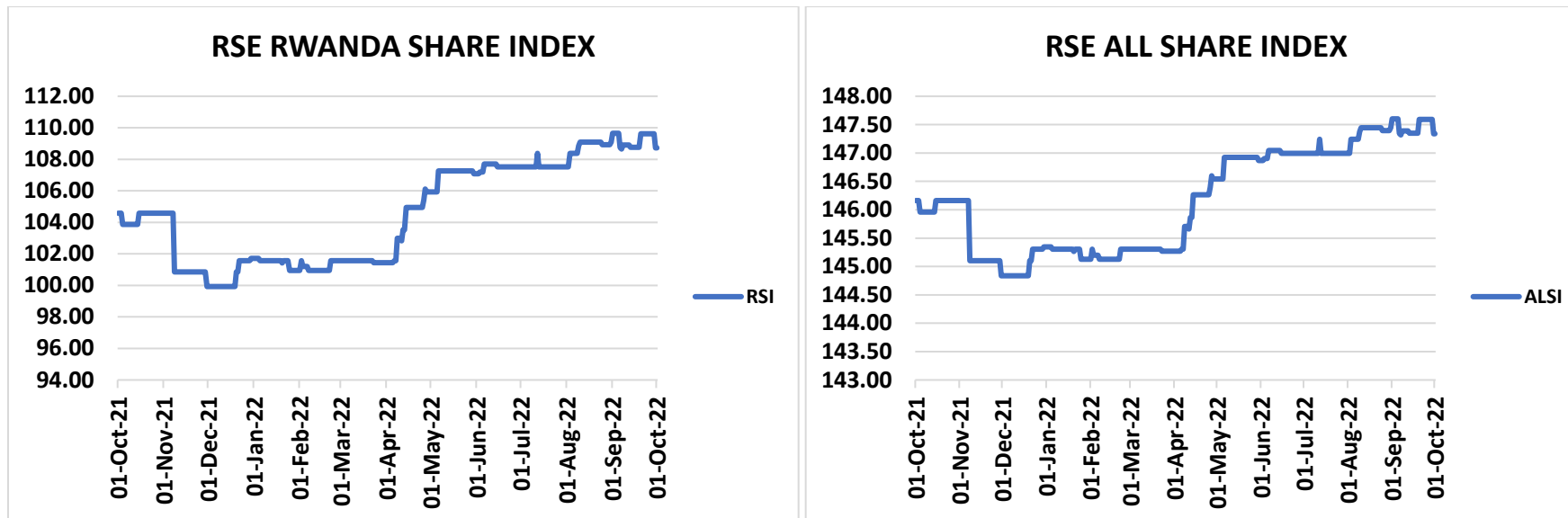
