



RWANDA STOCK EXCHANGE MARKET REPORT FOR WEDNESDAY 07TH SEPTEMBER 2022

1. Market overview

- The trading session recorded a turnover of Frw 199,908,500 from 745,700 shares traded in 4 deals on the equities market and Frw 4,093,600 worth of bonds traded in 2 deals on the fixed income market.
- RSI and ALSI went down by 0.08 and 0.02 points to close at 108.65 and 147.31 respectively.
- BOK counter closed at Frw 270 (Frw 272 previous). The trading session recorded a total turnover of Frw 198,612,000 from 735,600 shares traded in 1 deal.
- IMR counter closed at Frw 43 (Frw 42 previous). The trading session recorded a total turnover of Frw 129,000 from 3,000 shares traded in 1 deal.
- BLR counter closed at Frw 165 (Frw 165 previous). The trading session recorded a total turnover of Frw 1,167,500 from 7,100 shares traded in 2 deals.
- Equities counters closed as follows: CMR: Frw 120; MTNR: Frw 176; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

2. Closing bell

At the end of the formal trading hours; On the BOK counter, there was an outstanding offer of 356,900 shares at Frw 290 and an outstanding bid of 23,000 shares between Frw 245 - 265. On MTNR counter, there were outstanding offers of 1,133,700 shares between Frw 176 - 180 and no bids. On BLR counter, there were outstanding offers of 58,700 shares at Frw 165 and no bids. On IMR counter, there were outstanding offers of 69,800 shares at Frw 43 and an outstanding bid of 50,000 shares at Frw 40. On CMR counter, there were outstanding offers of 101,800 shares at Frw 120 and no bids.

On the bonds market, there were no offers and no bids.

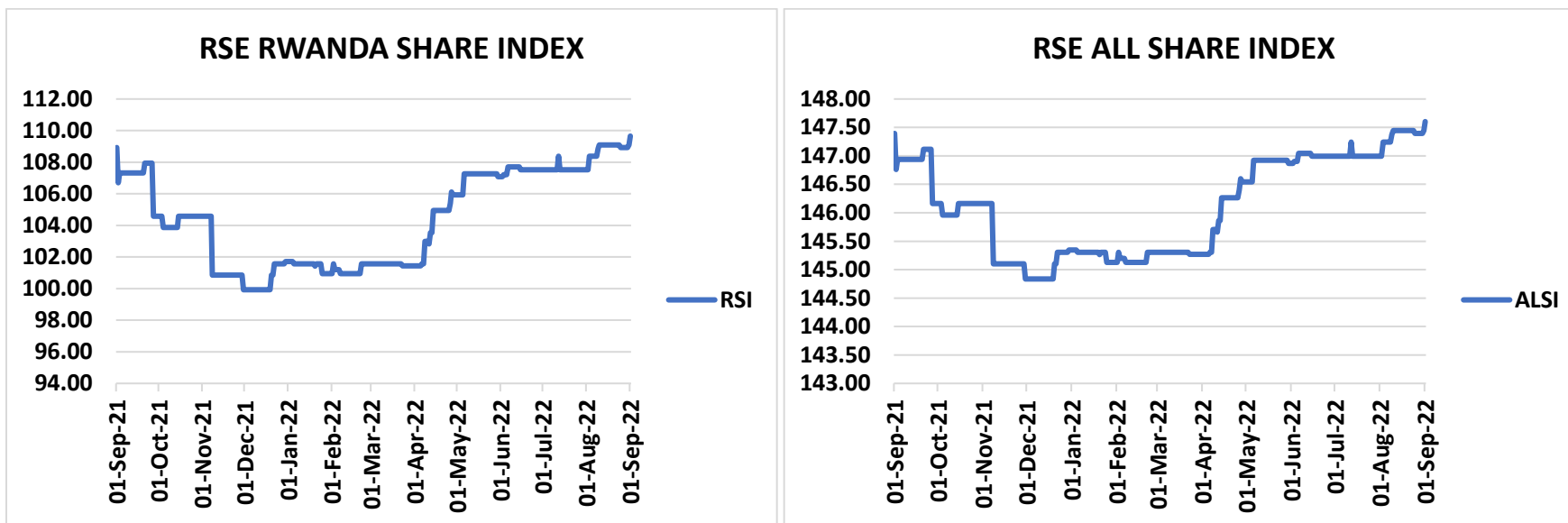
