



RWANDA STOCK EXCHANGE MARKET REPORT FOR WEDNESDAY 08TH DECEMBER 2021

1. Market overview

- The trading session recorded a turnover of Frw 206,126,200 worth of bonds traded in 5 deals on the fixed income market and Frw 96,000 from 800 BLR shares traded in 1 deal on the equities market.
- RSI and ALSI remained constant to close at 100.86 and 145.10 respectively.
- BLR counter closed at Frw 120 (Frw 120 previous). The trading session recorded a total turnover of Frw 96,000 from 800 shares traded in 1 deal.
- Equities counters closed as follows: BOK: Frw 250; IMR: Frw 45; CMR: Frw 120; MTNR: Frw 180; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

2. Closing bell

At the end of the formal trading hours; On BOK counter, there was an outstanding offer of 20,700 shares at Frw 250 and no bids. On MTNR counter, there were outstanding offers of 470,600 shares between Frw 180-195 and no bids. On BLR counter, there was outstanding offer of 30,200 shares at Frw 120 and outstanding bids of 110,000 shares between Frw 115-116. On CMR counter, there was an outstanding offer of 100,000 shares at Frw 120 and no bids. On IMR counter, there were outstanding offers of 428,700 shares at Frw 45 and no bids.

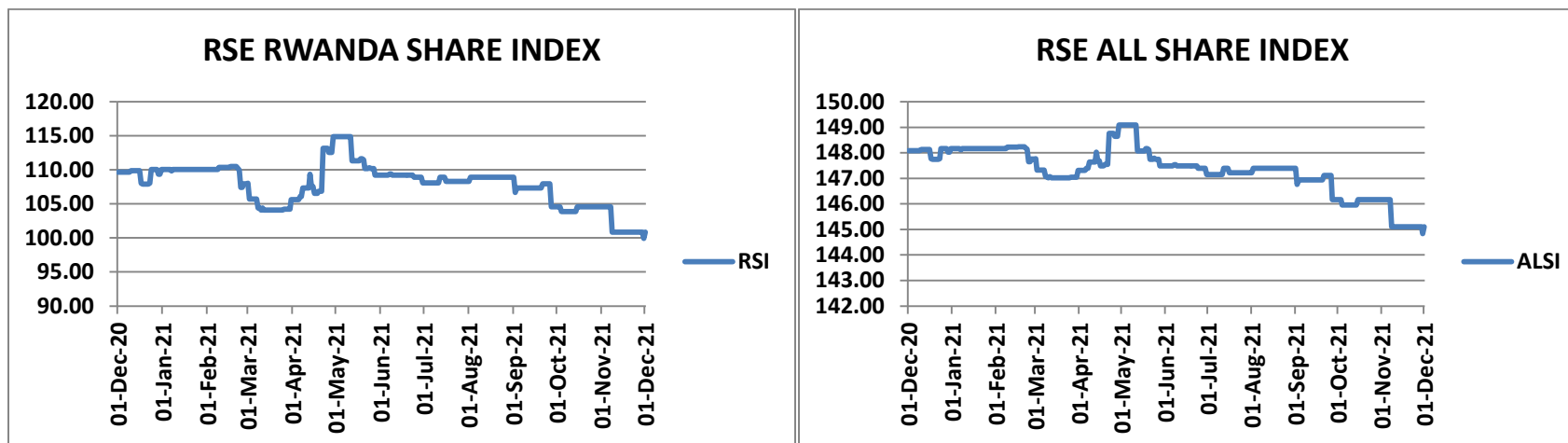
