



RWANDA STOCK EXCHANGE MARKET REPORT FOR WEDNESDAY 08TH JANUARY, 2020

1. Market overview

- Both RSI and ALSI went down 0.38 and 0.06 points to close at 123.02 and 135.52 respectively.
- Today's trading session recorded a total of Frw 13,980,600 from 157,900 shares traded in 7 deals and Frw 590,984,000 worth of bond traded in 2 deals.
- CTL counter closed at Frw 65 (Frw 70 previous). The trading session recorded a total turnover of Frw 8,894,000 from 136,500 shares traded in 3 deals.
- BOK counter closed at Frw 265 (Frw 265 previous). The trading session recorded a total turnover of Frw 4,584,500 from 17,400 shares traded in 2 deals.
- BLR counter closed at Frw 139 (Frw 139 previous). The trading session recorded a total turnover of Frw 403,100 from 2,900 shares traded in 1 deal.
- IMR counter closed at Frw 90 (Frw 90 previous). The trading session recorded a total turnover of Frw 99,000 from 1,100 shares traded in 1 deal.
- Equities counters closed as follows: KCB: Frw 370; EQTY: Frw 350; NMG: Frw 1200 and USL: Frw 104.

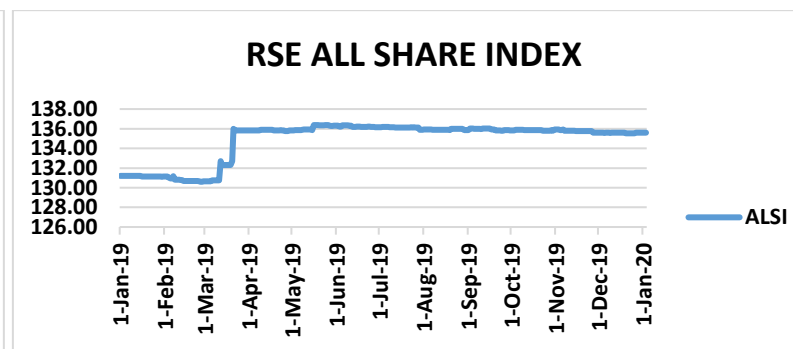
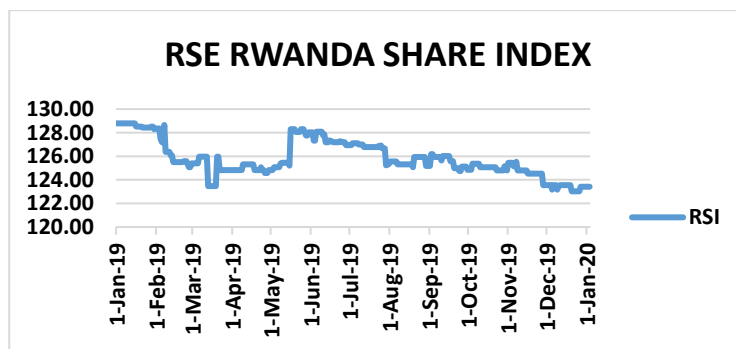
