



## RWANDA STOCK EXCHANGE MARKET REPORT FOR WEDNESDAY 08<sup>TH</sup> JUNE 2022

### 1. Market overview

- The trading session recorded a turnover of Frw 266,445,345 worth of bonds traded in 3 deals on the fixed income market and Frw 12,898,800 from 53,600 shares traded in 8 deals on the equities market.
- RSI and ALSI went up by 0.49 and 0.14 points to close at 107.70 and 147.04 respectively.
- BOK counter closed at Frw 265 (Frw 261 previous). The trading session recorded a total turnover of Frw 12,301,200 from 46,700 shares traded in 5 deals.
- BLR counter closed at Frw 160 (Frw 160 previous). The trading session recorded a total turnover of Frw 417,000 from 2,700 shares traded in 2 deals.
- IMR counter closed at Frw 43 (Frw 43 previous). The trading session recorded a total turnover of Frw 180,600 from 4,200 shares traded in 1 deal.
- Equities counters closed as follows: CMR: Frw 120; MTNR: Frw 178; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

### 2. Closing bell

At the end of the formal trading hours; On BOK counter, there were outstanding bids of 52,000 shares between Frw 255 – 261 and no offer. On MTNR counter, there were outstanding offers of 985,600 shares between Frw 177 - 180 and no bids. On BLR counter, there were outstanding offers of 35,500 shares between Frw 155 - 160 and no bids. On IMR counter, there were outstanding offers of 327,100 shares between Frw 43 - 45 and no bids. On CMR counter, there were outstanding offers of 114,200 shares at Frw 120 and no bids.

On the bonds market, there was no outstanding offer and no bids.

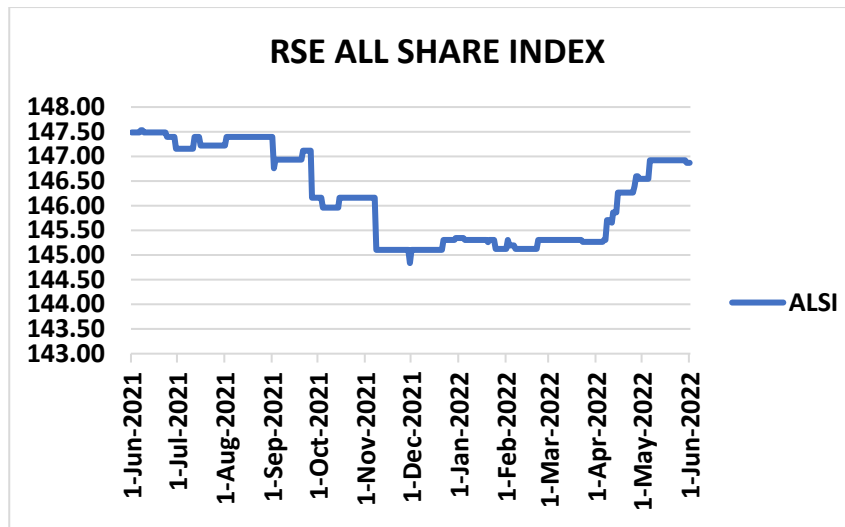
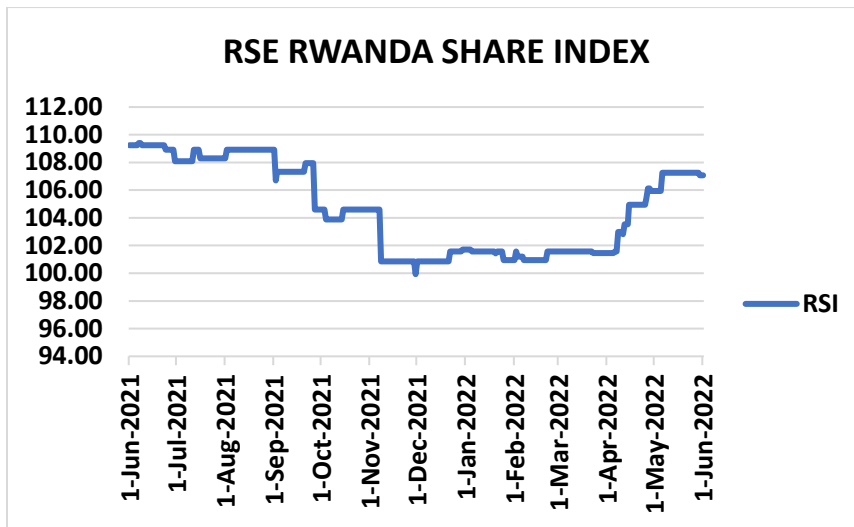

## 6. CORPORATE NEWS

- MTN Rwandacell Plc:** The Annual General Meeting of shareholders held on 2<sup>nd</sup> June 2022 approved a final dividend for the year ended 31 December 2021 of Frw 4.98 per ordinary share totaling Frw 6,727,083,900 only. The dividend payment will be made by 30<sup>th</sup> June 2022 to all shareholders on the share register by 9<sup>th</sup> June 2022.
- Equity Group Holdings Plc:** The Board of Directors has recommended a dividend of Kenya Shillings three (3.00) for each ordinary share on the issued and paid-up share capital of the company for the financial year ended 31<sup>st</sup> December 2021. Subject to shareholders approval, dividend will be payable on or before 30<sup>th</sup> June 2022 to the members of the Company on the share register of the Company on the closure date of 20<sup>th</sup> May 2022. The Annual General Meeting will be held on 29<sup>th</sup> June 2022.
- I&M Bank Rwanda Plc:** The Annual General Meeting of shareholders held on 27<sup>th</sup> May 2022 approved a final dividend of Frw 1.2 per share payable on 24<sup>th</sup> June 2022 or thereabout to the Shareholders of the Bank registered in the register of members as at the close of business on the 3<sup>rd</sup> June 2022.

- **BK Group Plc:** The Board of Directors has recommended a final and full dividend of Frw 28.7 for each ordinary share on the issued and paid-up share capital of the company at the Annual General Meeting (AGM) to be held on 17<sup>th</sup> June 2022. This represents a 50% pay-out ratio of the Group's Net income for the year ended 31<sup>st</sup> December 2021. The dividend will be payable on or around 1<sup>st</sup> July 2022 to the members of the Company on the share register of the Company at the close of business on Wednesday 22<sup>nd</sup> June 2022.
- **Bralirwa Plc:** The Annual General Meeting of shareholders held on 11<sup>th</sup> May 2022 approved and declared a dividend of Frw 17.05 per share. The book close date for Bralirwa shares was 16<sup>th</sup> May 2022 and the final dividend will be paid on 11<sup>th</sup> June 2022.
- **KCB Group Plc:** The Annual General Meeting of shareholders held on 3<sup>rd</sup> June 2022 approved that the interim dividend of Kshs. 1.00 per ordinary share paid on 5<sup>th</sup> January 2022 be confirmed and a first and final dividend of Kshs. 2.00 per ordinary share, payable, net of withholding tax, on or before 7<sup>th</sup> July 2022 to shareholders on the Register of Members at the close of business on 25<sup>th</sup> April 2022 be and is hereby approved.
