



## RWANDA STOCK EXCHANGE MARKET REPORT FOR WEDNESDAY 09<sup>TH</sup> FEBRUARY 2022

### 1. Market overview

- The trading session recorded a turnover of Frw 166,860,000 worth of bonds traded in 3 deals on the fixed income market and Frw 3,038,000 from 12,400 BOK shares traded in 1 deal on the equities market.
- RSI and ALSI remained constant to close at 100.94 and 145.12 respectively.
- BOK counter closed at Frw 245 (Frw 245 previous). The trading session recorded a total turnover of Frw 3,038,000 from 12,400 shares traded in 1 deal.
- Equities counters closed as follows: BLR: Frw 125; IMR: Frw 45; CMR: Frw 120; MTNR: Frw 180; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

### 2. Closing bell

At the end of the formal trading hours; On BOK counter, there were outstanding offers of 39,800 shares at Frw 250 and outstanding bids of 32,400 shares between Frw 240-245. On MTNR counter, there were outstanding offers of 750,000 shares at Frw 180 and no bids. On BLR counter, there were outstanding offers of 95,800 shares at Frw 125 and no bids. On IMR counter, there were outstanding offers of 560,000 shares at Frw 45 and no bids. On CMR counter, there were outstanding offers of 100,000 shares at Frw 120 and no bids.

On the bonds market; there was no outstanding offer and no bids.

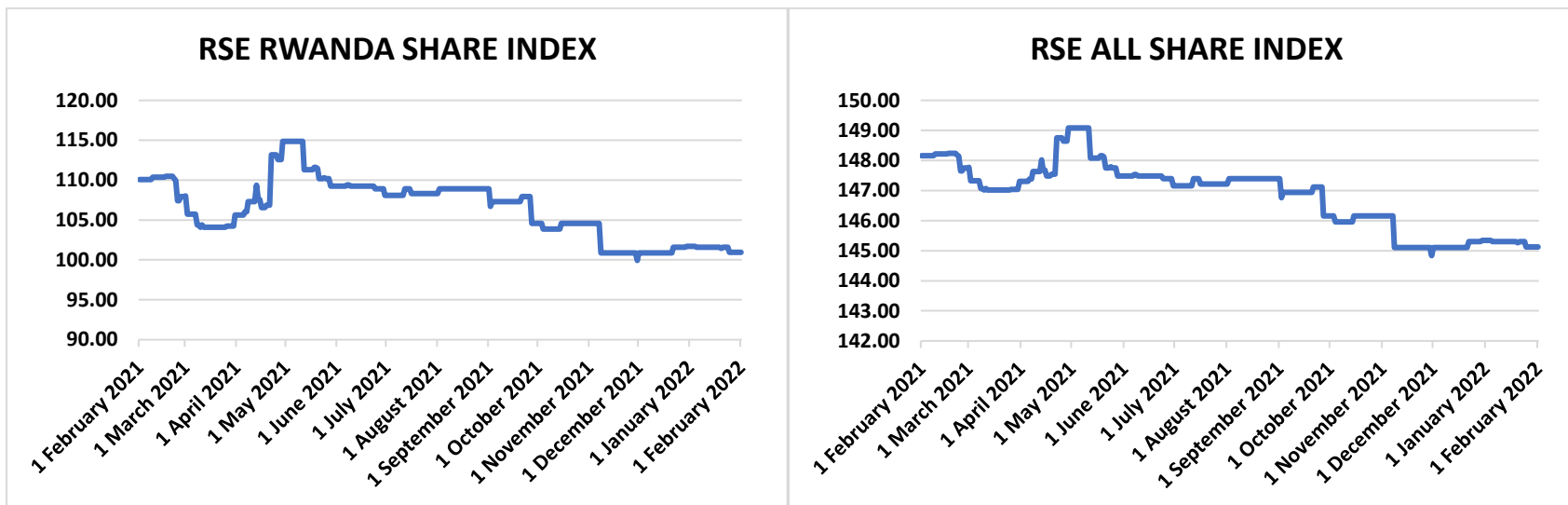
