



RWANDA STOCK EXCHANGE MARKET REPORT FOR WEDNESDAY 11TH AUGUST 2021

1. Market overview

- Today's trading session recorded a turnover of Frw 163,420,350 worth of bonds traded in 5 deals on the fixed income market and Frw 1,624,500 from 14,800 shares traded in 5 deals on the equities market.
- RSI and ALSI remained constant to close at 108.92 and 147.39 respectively.
- BOK counter closed at Frw 240 (Frw 240 previous). The trading session recorded a total turnover of Frw 1,032,000 from 4,300 shares traded in 1 deal.
- IMR counter closed at Frw 45 (Frw 45 previous). The trading session recorded a total turnover of Frw 400,500 from 8,900 shares traded in 3 deals.
- BLR counter closed at Frw 120 (Frw 120 previous). The trading session recorded a total turnover of Frw 192,000 from 1,600 shares traded in 1 deal.
- Equities counters closed as follows: CMR: Frw 120; MTNR: Frw 230; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

2. Closing bell

At the end of the formal trading hours; on BOK counter, there was an outstanding offer of 25,700 shares at Frw 240 and no bids. On MTNR counter, there were outstanding offers 1,299,400 shares between Frw 220-250 and no bids. On BLR counter, there were outstanding offers of 50,900 shares between Frw 120-125 and no bids. On CMR counter, there was an outstanding offer of 100,000 shares at Frw 120 and no bids. On IMR counter, there were outstanding offers of 925,000 shares between Frw 45-47 and no bids.

On bonds market; there was an outstanding offer of 7,000,000 at Frw 106 and no bids.

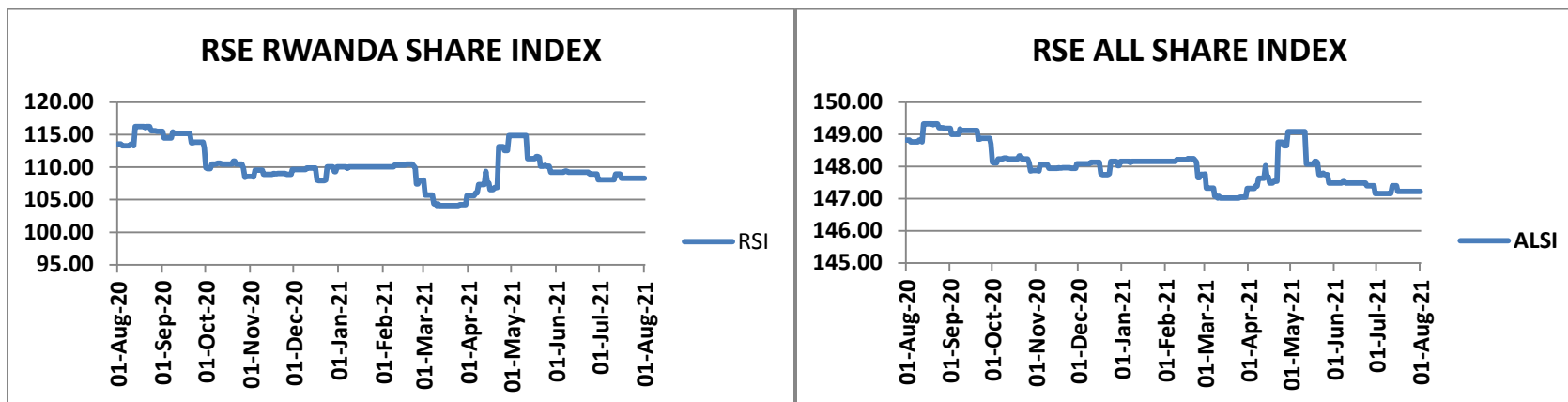
