



RWANDA STOCK EXCHANGE MARKET REPORT FOR WEDNESDAY 11TH JANUARY 2023

1. Market overview

- The trading session recorded a turnover of Frw 12,480,000 worth of bonds traded in 1 deal on the fixed income market and Frw 3,372,500 from 21,000 MTNR shares traded in 3 deals on the equities market.
- RSI and ALSI remained constant to close at 109.76 and 142.77 respectively.
- MTNR counter closed at Frw 175 (Frw 175 previous). The trading session recorded a total turnover of Frw 3,372,500 from 21,000 shares traded in 1 deal.
- Equities counters closed as follows: BLR: Frw 170; BOK: Frw 272; IMR: Frw 45; CMR: Frw 120; EQTY: Frw 440; KCB: Frw 328; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

2. Closing bell

At the end of the formal trading hours; On the BOK counter, there was an outstanding offer of 32,100 shares at Frw 272 and no bids. On MTNR counter, there were outstanding offers of 1,212,100 shares between Frw 175 - 180 and no bids. On BLR counter, there were outstanding offers of 33,700 shares at Frw 170 and no bids. On IMR counter, there were outstanding offers of 253,900 shares at Frw 45 and no bids. On CMR counter, there was an outstanding bid of 3,900 shares between Frw 120 - 122 and no offers.

On the bonds market, there were no offers and no bids.

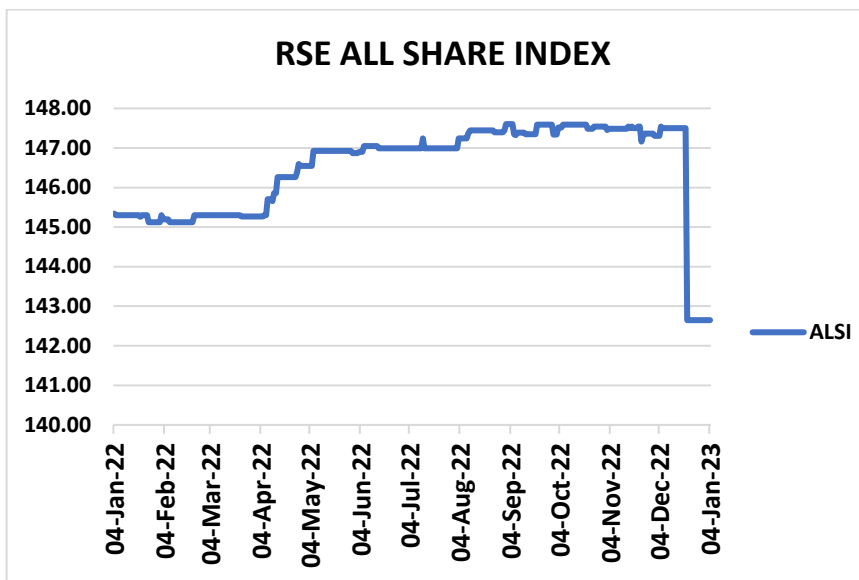
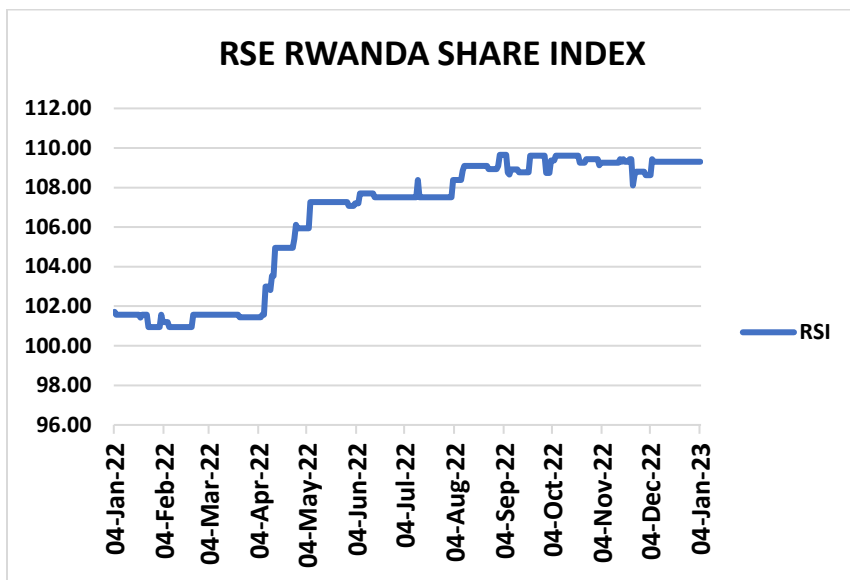
