



RWANDA STOCK EXCHANGE MARKET REPORT FOR WEDNESDAY 12TH OCTOBER 2022

1. Market overview

- The trading session recorded a total turnover of Frw 457,500 from 5,600 shares traded in 5 deals on the equities market while the fixed income market remained quiet.
- RSI and ALSI remained constant to close at 109.61 and 147.59 respectively.
- IMR counter closed at Frw 43 (Frw 43 previous). The trading session recorded a total turnover of Frw 150,500 from 3,500 shares traded in 2 deals.
- BLR counter closed at Frw 170 (Frw 170 previous). The trading session recorded a total turnover of Frw 187,000 from 1,100 shares traded in 2 deals.
- CMR counter closed at Frw 120 (Frw 120 previous). The trading session recorded a total turnover of Frw 120,000 from 1,000 shares traded in 1 deal.

- Equities counters closed as follows: BOK: Frw 272; MTNR: Frw 176; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

2. Closing bell

At the end of the formal trading hours; On the BOK counter, there were outstanding offers of 78,000 shares between Frw 272 - 280 and no bids. On MTNR counter, there were outstanding offers of 1,236,000 shares between Frw 176 - 180 and no bids. On BLR counter, there was an outstanding offer of 2,100 shares at Frw 170 and no bids. On IMR counter, there were outstanding offers of 228,000 shares between Frw 43 - 45 and no bids. On CMR counter, there were outstanding offers of 104,700 shares at Frw 120 and no bids.⁷

On the bonds market, there were no offers and no bids.

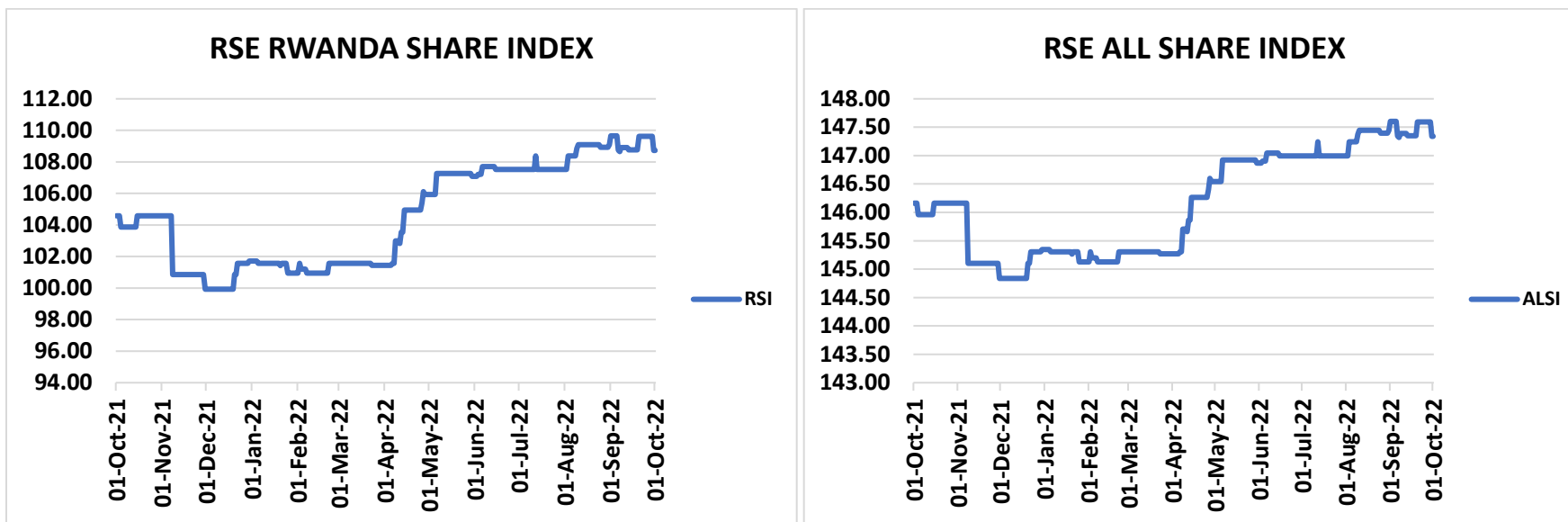
