



RWANDA STOCK EXCHANGE MARKET REPORT FOR WEDNESDAY 13TH OCTOBER 2021

1. Market overview

- The trading session recorded a turnover of Frw 3,669,600 worth of bonds traded in 4 deals on the fixed income market and Frw 1,145,000 from 5,800 shares traded in 3 deals on the equities market
- RSI and ALSI remained constant to close at 103.88 and 145.95 respectively.
- MTNR counter closed at Frw 200 (Frw 200 previous). The trading session recorded a total turnover of Frw 400,000 from 2,000 shares traded in 1 deal.
- BOK counter closed at Frw 250 (Frw 250 previous). The trading session recorded a total turnover of Frw 700,000 from 2,800 shares traded in 1 deal.
- IMR counter closed at Frw 45 (Frw 45 previous). The trading session recorded a total turnover of Frw 45,000 from 1,000 shares traded in 1 deal.
- Equities counters closed as follows: BLR: Frw 115; CMR: Frw 120; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

2. Closing bell

At the end of the formal trading hours; On MTNR counter, there were outstanding offers of 1,050,000 shares between Frw 200-225 and no bids. On BOK counter, there was an outstanding offer of 15,400 shares at Frw 260 and no bids. On BLR counter, there were outstanding offers of 112,100 shares between Frw 120-125 and an outstanding bid of 10,000 shares at Frw 115. On CMR counter, there were outstanding offers of 110,200 shares at Frw 120 and no bids. On IMR counter, there were outstanding offers of 374,100 shares between Frw 45-47 and no bids.

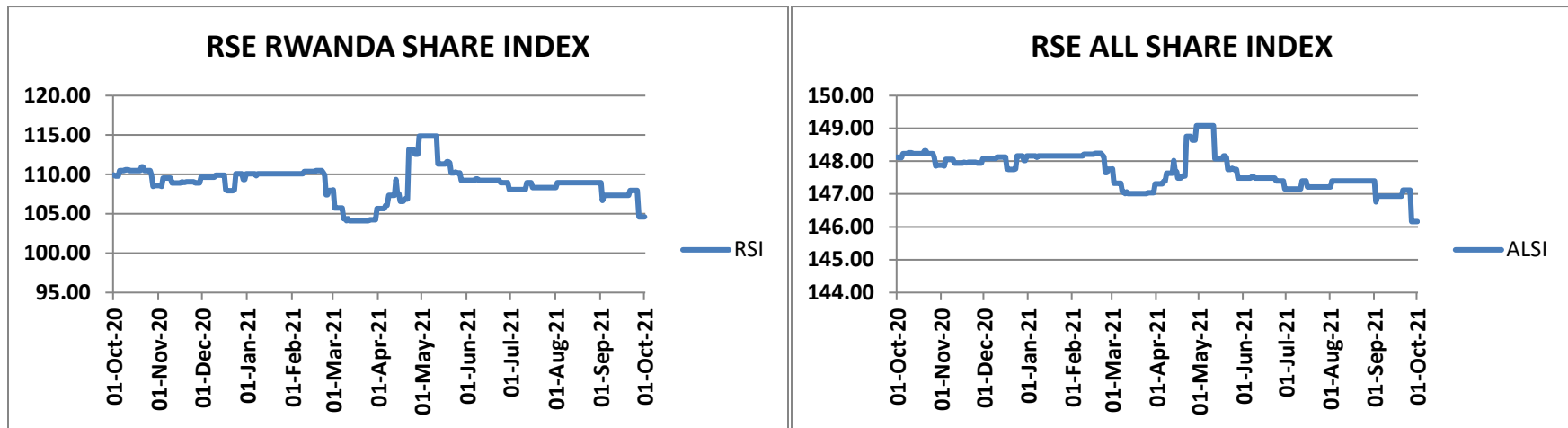
