



## RWANDA STOCK EXCHANGE MARKET REPORT FOR WEDNESDAY 14<sup>TH</sup> SEPTEMBER 2022

### 1. Market overview

- The trading session recorded a turnover of Frw 103,792,600 from 385,800 shares traded in 3 deals on the equities market and Frw 20,537,040 worth of bonds traded in 2 deals on the fixed income market.
- RSI and ALSI remained constant to close at 108.77 and 147.35 respectively.
- BOK counter closed at Frw 272 (Frw 272 previous). The trading session recorded a total turnover of Frw 103,577,600 from 380,800 shares traded in 2 deals.
- IMR counter closed at Frw 43 (Frw 43 previous). The trading session recorded a total turnover of Frw 215,000 from 5,000 shares traded in 1 deal.

- Equities counters closed as follows: BLR: Frw 164; CMR: Frw 120; MTNR: Frw 176; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

### 2. Closing bell

At the end of the formal trading hours; On the BOK counter, there were outstanding offers of 356,900 shares at Frw 290 and outstanding bids of 23,000 shares between Frw 245 - 265. On MTNR counter, there were outstanding offers of 1,133,400 shares between Frw 176 - 180 and no bids. On IMR counter, there were outstanding offers of 71,800 shares at Frw 43 and no bids. On CMR counter, there were outstanding offers of 101,700 shares at Frw 120 and no bids.

On the bonds market, there were no offers and no bids.

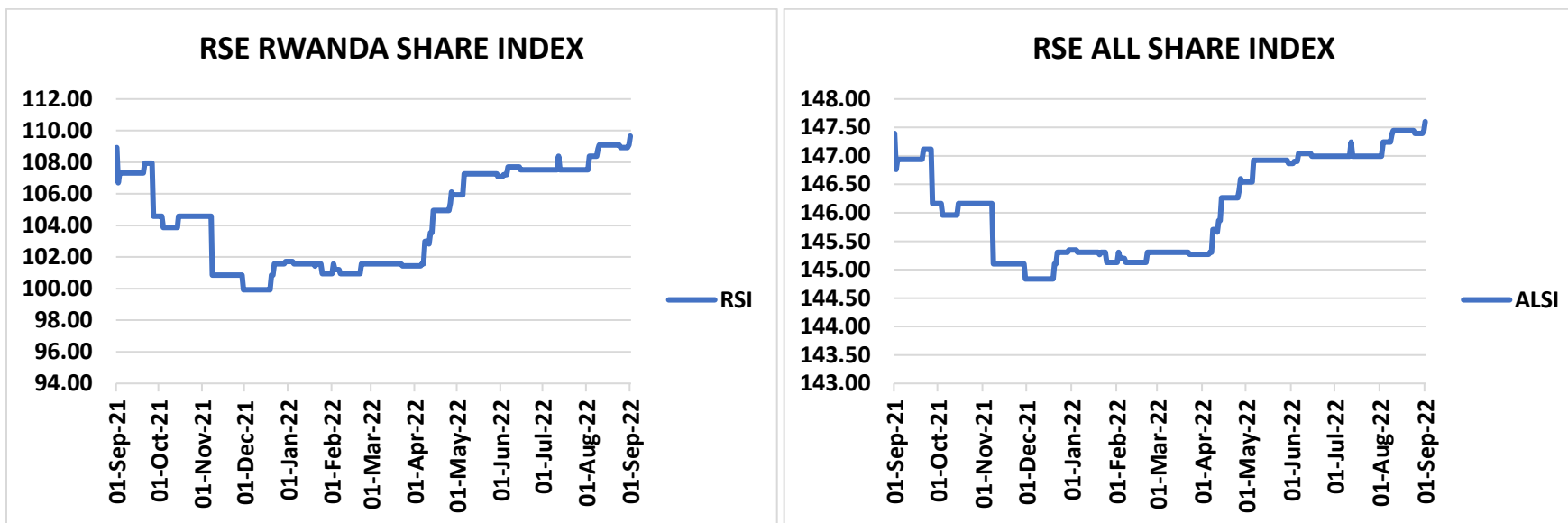
