



RWANDA STOCK EXCHANGE MARKET REPORT FOR WEDNESDAY 15TH DECEMBER 2021

1. Market overview

- The trading session recorded a turnover of Frw 1,003,072,500 worth of bonds traded in 2 deals on the fixed income market and Frw 44,935,500 from 379,400 shares traded in 4 deals on the equities market.
- RSI and ALSI remained constant to close at 100.86 and 145.10 respectively.
- IMR counter closed at Frw 45 (Frw 45 previous). The trading session recorded a total turnover of Frw 355,500 from 7,900 shares traded in 1 deal.
- BLR counter closed at Frw 120 (Frw 120 previous). The trading session recorded a total turnover of Frw 44,580,000 from 371,500 shares traded in 3 deals.
- Equities counters closed as follows: BOK: Frw 250; CMR: Frw 120; MTNR: Frw 180; EQTY: Frw 440; KCB: Frw 370; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

2. Closing bell

At the end of the formal trading hours; On BOK counter, there was an outstanding offer of 32,600 shares at Frw 250 and no bids. On MTNR counter, there were outstanding offers of 506,600 shares between Frw 180-195 and no bids. On BLR counter, there was an outstanding bid of 100,000 shares at Frw 116 and no offer. On CMR counter, there was an outstanding offer of 100,000 shares at Frw 120 and no bids. On IMR counter, there were outstanding offers of 273,900 shares at Frw 45 and no bids.

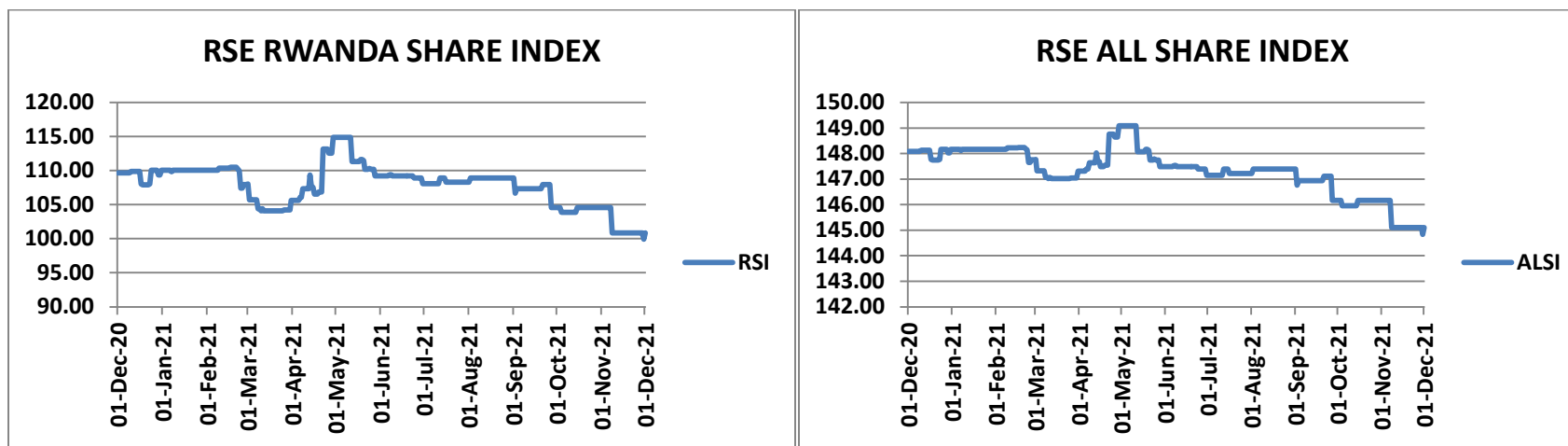
